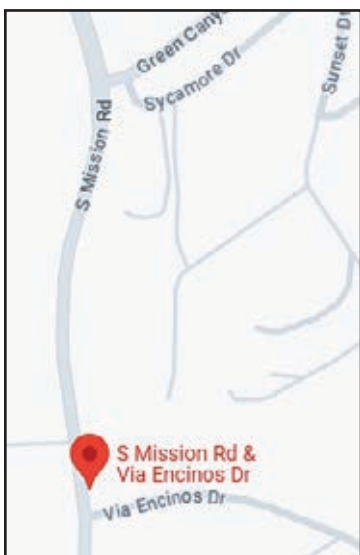

South Mission Road closure announced



SAN DIEGO – San Diego Gas & Electric advises Fallbrook residents that South Mission Road, between Green Canyon Road and Via Encinos Drive, will be reduced to a single lane between the hours of 8 a.m. and 5:30 p.m. Tuesday, May 28 – Friday, May 31.

Traffic control will be in place to assist drivers through the work area. The lane closures are necessary for crews to safely install new overhead power lines. The work is part of SDG&E's efforts to help reduce the risk of wildfires by replacing wood power poles with taller, fire-resistant steel poles.

Victims identified from tragic collision

In a devastating collision on Friday night, May 10, 2024, four lives were tragically lost, and one Fallbrook resident fights for recovery after a head-on crash near the intersection of Pala Rd and Horse Ranch Creek Rd. The incident has left several communities mourning the loss of loved ones and grappling with the aftermath of the tragic event.

Albert Gary Salazar, a 60-year-old Fallbrook resident, was behind the wheel of a white Jeep Gladiator with three passengers. The Jeep was struck head-on by a gray Chrysler 300 traveling in the wrong direction along the westbound lanes of SR 76. Mr. Salazar succumbed to blunt force trauma at the scene, according to the San Diego Coroner's office. His wife, Patty Salazar, who was a passenger in the Jeep, miraculously survived the collision but remains in the intensive care unit at Palomar Medical Center, battling serious injuries, as confirmed by a family friend. It is reported that she has

a long road of recovery ahead, but she has the support of her neighbors and family.

Neighbor Clint Worthington described the Salazars as an inspiring couple with a remarkable

love story. Albert and Patty married in Italy and were relatively new residents to Fallbrook, having moved from Anaheim Hills 2 ½ to 3 years ago. Worthington, reminisced about he and Albert's

shared love of Corvettes and Harleys, noting their recent trip to Julian on their Harleys with their wives as a memorable trip that the

Residents addressing "bad doughnuts" in intersection

San Diego County traffic engineers met with residents of the Clearcrest/Winterhaven neighborhood on Friday morning, May 17, to discuss possible deterrents to people speeding and doing "bad doughnuts" in their intersection.

According to neighbors at the meeting, some people have been nearly hit while the cars are doing "doughnuts" in the wide intersection.

Organizer Karl Higgins served "good doughnuts" while exchanging ideas with the engineers, such as rumble strips, additional reflectors in the street, license plate readers and CHP Traffic cameras mounted on utility poles, education of the community, signage for the school zone, cleanup of the marks in the street, trimming of trees, and lights.

At the end of the meeting, Higgins said, "Here is a punchlist of items the Public Works/County

West Coast Thunder set for Memorial Day

West Coast Thunder is expected to bring more than 7,500 motorcycle riders to Riverside and the surrounding communities for the annual ride honoring members of the armed services this Memorial Day.

Scheduled to kick off in the morning Monday, May 27, at Riverside Harley-Davidson, 7688 Indiana Avenue, the celebrated motorcycle ride throughout the area includes a 53-mile trip along two freeways and will end at Diamond Stadium with a concert featuring Chayce Beckham.

“We are excited to bring together the community again for a memorable and meaningful celebration of our veterans’ valor

and sacrifice,” Jackson Dodd, executive director of West Coast Thunder Foundation, said.

West Coast Thunder was first held in 2000 when the dealership belonged to Skip Fordyce and operated under that banner, according to City News Service.

The thousands of motorcyclists bearing American flags and other ensigns will start to gather around 6 a.m. that day before departing the dealership with a police escort at 9:11 a.m. and kick off their ride up Alessandro Boulevard to south Riverside, “where residents regularly gather on sidewalks to wave and show support,” City News Service said.

From Alessandro Boulevard, the ride will take Van Buren Boulevard, where some of the riders will head to Riverside National Cemetery

to pay their respects, with the remaining riders continuing onto Interstate 215 south to Murrieta.

After arriving in Murrieta, riders will then swing over to northbound Interstate 15 and ride to Lake Elsinore’s Diamond Stadium where Beckham, a singer-songwriter from Apple Valley, who rose to fame in 2021 after winning the 19th season of the singing reality show American Idol, will perform.

“We’re thrilled to welcome back West Coast Thunder to Diamond Stadium for their annual Memorial Day event,” Mark Beskid, general manager of Storm Events at Diamond Stadium, said. “Their passion for the community and commitment to our nation’s heroes align perfectly with our values, and we’re honored to host them once again.”

For those who want to participate, but who don’t own a motorcycle, concert tickets are available online at <http://www.westcoastthunder.com>. The event will also feature a car show and a vendor village, with an expanded variety of food options and an increased number of concession stands and food trucks available throughout Diamond Stadium.

Lake Elsinore Diamond Stadium is located at 500 Diamond Drive in Lake Elsinore.

According to organizers, the West Coast Thunder Memorial Day Motorcycle Ride has grown year-over-year, bringing more than 10,000 riders and spectators to Riverside, many lining the streets to watch the parade travel through the city.

The foundation is dedicated to funding the American Indian Veterans Memorial, which broke ground in 2020.

The state is raising our electricity bill

A few months back, I wrote about the state of California's ill-conceived plan to charge electricity based on income. Thanks to our collective outcry, that proposal was rightfully defeated. However, our voices were not heard loud enough, as the state has now introduced a similar flawed scheme.

The California Public Utilities Commission has approved an additional \$24 monthly charge on most electricity bills, amounting to a staggering \$288 in new fees annually. This imposition will hit working-class families hardest, exacerbating the already challenging task of affording life in our state.

As Californians, we already bear one of the nation's highest

electricity price tags, and this new directive only means more of our hard-earned money flowing into state coffers.

Here's the breakdown: households with one or two individuals earning below \$39,440 will see a \$6 monthly increase; those earning between \$39,440 and \$62,150 will face a \$12 monthly charge, while individuals making \$62,150 or more will be saddled with a monthly fee of \$24.50.

It's essential to note that these charges are irrespective of whether you have solar panels, making solar investments less economical. This approach also disincentivizes energy conservation, as consumers will now bear a fixed monthly cost on top of their usage.

Also, California electricity prices have risen 50% since 2017 and are now double the national average.

I've always advocated for a fair principle: the more you use, the more you pay. Electric companies already offer programs to aid those in need, but this new fee structure, tied to income and disincentivizing conservation, is not the solution.

It's time to take action. I urge each of you to contact your state representatives and demand a reversal of this decision. Together, we can ensure that Californians are not burdened unfairly and that our electricity policies promote fairness and sustainability.

California's budget

Last week, the Governor released his "May Revise," which is based on revenues received since January when the preliminary \$291.5 billion budget proposal (\$208.7 General Fund) was released. The Revise now estimates a \$27 billion budget deficit, even though a report from the Legislative Analyst's Office forecasts a much higher deficit of \$55 billion.

The new budget proposal is

aimed at creating a balanced budget over two years. Expanding some programs will be paused temporarily, and other savings will result from the targeted elimination of 10,000 unfilled positions. The budget seeks to reduce non-essential spending, and to eliminate bureaucratic red tape.

The administration is proposing to cut \$1.3 billion from important behavioral health programs, including from youth mental health. \$11 million will be cut from programs in our prisons that help treat substance abuse and reduce recidivism. \$895 million will be spent electrifying school buses, while funding for school facilities, middle class scholarships, and important kindergarten programs will be cut. Unfortunately, the budget still includes funding for costly and unnecessary projects like high speed rail, which will receive \$1 billion annually. Californians continue to struggle with inflation and cost of living increases, yet things will soon get worse with another gas tax increase.

As the Vice Chair of the

Assembly Health Committee, I am concerned by the proposed cuts of \$420 million to behavioral mental health programs across the state. Those cuts will affect our children by decreasing funding to the Children and Youth Behavioral Health Initiative.

The May Revise is just a start, which begins the process that will lead to a final budget. I am looking forward to joining my colleagues on both sides of the aisle to build on the Governor's proposal. As always, my emphasis will remain on spending taxpayer dollars wisely. Over the coming weeks, the legislature has a responsibility to deliver a balanced, sustainable budget that maintains vital services and prioritizes critical needs

Fear-mongering labels are how bigotry, dehumanization, and oppression of people are born. This is the mentality of hate, not love and understanding, and an attitude of cooperation so all individuals can feel they have come out better and are more unified as much as possible when meeting at the table to discuss important topics. Those demeaning labels steer people from inviting one another to the table to seek solutions with a belief in the best positive approach and cause division in such a lovely community as Fallbrook. Truly, labeling in negative ways only promotes divide, problems, and seeks to be dismissive and unkind to the "other" labeled. Is that the example we want to set for our children? Is that what we want as a country? Is that who we wish to be as individuals? Why not focus on understanding each other's perspectives better rather than making inaccurate assumptions and put-downs? Why not try to get to know one another and

work together on what we have in common because I bet we have a lot more than you realize in the end when you see people by their real name (not a label or group to be feared and hated) as your neighbor and look into often their very caring hearts?

A Christian is just someone who believes Jesus died on the cross to pay for the sins (poor, mistaken, or evil choices) of EVERYONE in the world and offers the gift of forgiveness to ANYONE (could you be more inclusive???) who wants to have it so their relationship with God can be restored and thrive. This is how God can remain both just and loving to his beloved creation. They love Jesus and try their best albeit imperfectly at times to love their neighbors. (For example, parents often pay for things their young kids break of a neighbor's because the cost is not something the child can afford, but in order to be just and address the damage and repair the relationship to a good one with the neighbor a loving parent steps in and does what would be very difficult for that young child to do. That is what our Heavenly Father has done for us for Eternity.)

A Nationalist is just someone who loves their country and the freedoms for which it stands and prefers smaller local governments where possible. Doesn't mean they think it has a perfect past or can't be improved. Yet, many Americans believe no matter our country's flaws, it is still the best place to try to get ahead in life and live freely more than anywhere else in the world, and we don't want the parts that make it free or the parts that provide for individuals to have a more impactful voice peacefully to be diminished. It does not mean you don't love other countries and the people there too or think you are better than them.

We still have a curiosity about and appreciation for all cultures (I personally have loved traveling the world and enjoy many of the differences in culture) and want to help when they struggle. It does mean you don't think it wise to give up National Sovereignty to a small group of people who think they are elites, smarter than, and know better than the individuals in their communities what is best for them and have little accountability because the bigger a government gets, the more far removed it gets from the variety and billions of people it serves, and the harder it is for those people to reach out and have a voice to the policies these few world dictators will impose.


So being a Christian Nationalist is not something to be ashamed of. Rather, it is quite an oxymoron and inaccurate, unkind behavior for someone in an effort to create fear between fellow humans and neighbors to justify being dismissive and inequitable to the concerns, needs, and opinions of those that love Jesus and their country and feel good about being so intolerant and non-inclusive in their hearts while claiming they love diversity of opinion, equity, and are oh so inclusive. Sadly, they don't see their own hypocrisy and the harm they are causing with such demeaning use of labels.

We can do better Fallbrook neighbors! We are the Friendly Village! Let's not buy into the world's lies that lead to disharmony between us.

Traffic Engineer will look into. The process also involves educating the public & offenders; researching engineering solutions; enforcement of existing laws on vehicle impoundment; and finally—short term and long term projects at the intersection as noted below:

Restripe the intersection to lengthen traffic lane lines and install many more reflective pavement markers on the surface of the road; Consider vertical lane delineators to prevent circular spinning; “Talk to the high school principals and let them know that enforcement is coming and let the kids know that their car may get impounded if they are caught; Set up the portable info trailer on the street at the intersection and provide notice that donuts will result in impounding your car.”

A local school bus driver noted that this is a problem in other places around town. Higgins and his neighbors are talking to the Fallbrook Planning group as well.

four of them took together.

Worthington said that Albert and Patty had met on Match.com. They both lived in the Anaheim Hills area but had decided to move to Fallbrook and found their new home in the Gird Valley. They had been remodeling and were enjoying their lives in their new town. He said Albert was getting ready to retire from Southern California Edison and was making the drive back and forth to the Anaheim area.

Tragically, two other passengers in the Jeep, Peggy Moore, 60, and her partner Hope Wood, 48, from the San Francisco area, also lost their lives in the collision. Ms. Wood, who has been reported to be Ms. Salazar’s niece, passed away from “obvious head and torso trauma,” as determined by the San Diego Coroner’s office. Peggy Moore, known for her 25 years of tireless political activism and advocacy for the rights of the LGBT community and communities of color, is also being mourned by friends, colleagues, and politicians alike.

Much has been reported on Peggy Moore and Hope Wood’s political work on various campaigns to their co-founding of Hope Action Change in 2019. U.S. Rep. Barbara Lee expressed,

“Both Peggy and Hope made an impact on our community, on our city, on our state, and on our nation that will be felt for generations to come.”

A community of Peggy & Hope’s extended family and friends have launched a GoFundMe campaign to support the unexpected financial burden of funeral expenses and the settling of Peggy Moore and Hope Wood’s funeral expenses. As of presstime, they have raised \$32,000 of a \$75,000 goal.

Reports indicate that Ms. Salazar’s sister and Ms. Wood’s mother also was involved in the accident and witnessed the unimaginable tragedy, but escaped serious injury as she was in a vehicle that was following behind the Jeep.

The impact of this tragic event extends far beyond the intersection where it occurred, leaving a void in the lives of those who knew and loved Albert Salazar, Peggy Moore, and Hope Wood. As Patty Salazar fights to recover, it appears she is surrounded by the support of her neighbors and loved ones.

Fallbrook Senior Center marks 50th with meals, magic, music and more

My home-away-from-home marked its 50th year in fine fettle last week. There was food, a vintage car show, a magician, music and dancing. And, of course, there was plenty of Pickleball.

The week began with the public unveiling of the Fallbrook Intergenerational Storyteller Project. That effort combines the experiences of local seniors and the technical expertise of area high school students to create mini-documentaries that will be posted online.

About 35 people munched snacks, watched the three initial offerings and heard about the effort that will further unfold June 1 and well into the future.

The most popular event of the

week-long celebration appeared to be a mariachi concert and a Mexican food lunch at the Fallbrook Community Center. I ate like a pig and danced like a fool. About 102 people packed the place.

Next up was magician Jerry Langford, whose resume was as intriguing as his show. The Lake Forest resident has worked as a radio announcer and a movie reviewer. He has driven demolition derby cars and won awards for his sand castle creations. He has performed his magic show at schools, on cruise ships and countless other locations.

About 40 people caught Langford's act, which relied heavily on optical illusions and slight-of-hand tricks.

Performer Barry Allen Cohen focused on music of the '50s and '60s. Myself and a couple of other

brave souls wore vintage clothes and kicked up our heels. That lunch show attracted about 80 guests who dined on barbecue ribs, cupcakes and other delights.

The events featured a fair share of looking back, but some of the organizers peered into the future. I have been blessed to have one foot in both worlds.

The nonprofit club is located at 399 Heald Lane in Fallbrook. It serves a 110.5-square-mile area that takes in Fallbrook, Rainbow, Bonsall and DeLuz. The club's approximately 640 members each pay \$15 a year to belong. That fee, which has not increased in at least 10 years, doesn't even cover the club's electric bill.

The nonprofit club, which was established in 1974, offers activities, classes, games and other services. Its thrift shop, which opened in the 1980s, is the club's chief source of operating funds.

Nearly 25% of the area's approximately 50,000 residents is comprised of adults age 65 or older, according to SANDAG, a regional planning group. Between 2020 and 2050, the population of Fallbrook-area adults age 75-79 will increase by more than 41%, ages 80-84 by 98% and 85 and older by nearly 150%.

"Has anybody heard the term 'silver tsunami'?" Senior center board member Mark J. Weaver asked an audience at one point.

That projected growth has left club leaders wondering how they will serve the region if the scope of their programs and the size of their 4,000-square-foot facility remain the same. The club has struggled with this dilemma since I served on its board more than a decade ago. These days I volunteer at the center when the mood suits me. I am often flabbergasted by the popularity of the place.

The anniversary celebration ended with a display of classic vehicles owned by members of the Fallbrook Vintage Car Club and a simultaneous concert by the Fallbrook Ukulele Strummers.

Scores of visitors and two dogs strolled through the parking lot examining nearly 20 vehicles and listening to the 21 musicians. My favorite car was a 1902 Oldsmobile Model R curved dash runabout that cost \$650 when it was brand new.

The activities struck a chord with the community. Jim Lyle, a 35-year Fallbrook resident, attended most of the luncheons and functions.

"They've all been great," he said. "They were a lot of fun."

"I had not seen a magician since I was in fourth grade," said Lyle, 77. "I wanted to be a magician when I grew up. My parents bought me a magic kit and I couldn't figure it out. It takes a lot of skill to be a magician. I also liked talking to the car guys. They have a lot of stories."

I always savor the music. One of the ukulele tunes – "Wagon Wheel" written by Bob Dylan and Ketch Secor – lingered in my mind the rest of the day.

"... So rock me mama like a wagon wheel. Rock me mama any way you feel. Rock me mama like the wind and the rain. Rock me mama like a southbound train ..."

It snowed again this morning! Even so by 10:00 AM, the sun was out and that's when we took a brisk walk back to the Museum of Art after being told yesterday by security guard Mike Saiz that all government-run museums are closed on Mondays.

With limited time in town, we could only explore around the plaza in the heart of downtown. Santa Fe maintains its charm because of their strict building code which mandates that all structures be made in the Adobe style. Which no doubt is why it was chosen as the first UNESCO city in America plus it is the oldest capital city in the US. And, as advertised, it is very walkable.

Here's the glitch. At 7000 feet above sea level, a deep breath can be hard to come by if you have a heart condition. Consequently, I was powered by VJ who dragged me along the sidewalks like a pull toy. I huffed and puffed my way through town, shuffling from one bench to another.

I didn't anticipate breathing troubles. Yet after the first night, when my sinus cavity became clogged, I woke with the worst case of dry mouth of my life. It was so dry my gums burned. Fortunately, I'd packed essentials like Biotene spray to rehydrate my mouth and saline spray to open my sinus.

You'd think that would be enough, however, my blood pressure decided to take a spike too. Even after I'd asked my doctors before leaving town if I should worry about anything. They said "not to worry". Let me assure you had I known I'd have rented an oxygen tank. Although we did hear there was an oxygen bar somewhere nearby.

While the city slogan is "hydrate" it doesn't forewarn that

the air is so dry it will pull the moisture back out of your body before you can even swallow it. Note: It's so dry, it practically sucks the moisture from your water bottle.

Today's plan was to see as much as we could before we went to our cooking class at 2:00 PM. The Santa Fe School of Cooking offers a variety of year-around classes in Mexican cuisine. Jeff enrolled us in the 2 o'clock session for Authentic Spanish Tapas Class. Or so I thought.

When the class was announced as the Red Chile Workshop, I am embarrassed to say, my disappointment showed badly. But as it always seems to happen, when I get in a snit and act like a goose, everything turns out.

With our instructor Chef Allen at the stove, he demonstrated how to prepare dried New Mexico chilies, but more importantly, he demonstrated how to de-hot them. After that, just by adding water and a heaping spoonful of lard to ground masa, Chef made tortilla dough for us to roll and press into rounds for frying in hot-well-seasoned cast-iron skillets.

Next it was all about the salsa. We used those New Mexico dried chilies and Roma tomatoes that we'd charred over a gas flame. Everything was delicious. With a dozen participants in our 2-hour class, we had lots of salsa recipes to sample. The surprise being that none of them turned out to be too hot for my delicate palate. As our last order of the day, we cleaned up our work stations before stopping in the kitchen store on the way out.

With our hotel only a block away from the school, we made it back in time for another stamp on our city-wide Margarita passport. With 50 choices, we picked the El Dorado Hotel since it was our home away from home. Which is why we simply dined on Happy Hour tapas washed down with half-priced margaritas at the Oasis

bar for our dinner.

Wednesday was our last full day to see the rest of the downtown sights. Even though many private galleries were still closed during the off season, we couldn't get to all of the ones that were open. Santa Fe houses over 200 fine art galleries plus a half a dozen or more museums, and throw in a few churches, there just wasn't time to see it all. Which is why we didn't even scratch the surface when we saw the ones around the plaza. There are so many more galleries on Canyon Road's Museum Hill plus the Art District at the Railyard.

There are also lots of jewelry stores. That's when I found out my old-pawn squash blossom necklace

was now worth \$15,000.00. After that evaluation, I needed a margarita. Upstairs was the Coyote Cantina so I didn't have to go far. After lunch we went to both Owen Gallery locations to find Page Allen (the lady we'd met in Paris in 2012 at the Pompidou Modern Art Museum over lunch) only to discover she was enroute to Paris.

Heading back to our hotel we peaked in the courtyard at Grant and West Palace streets after a sign with a beautiful Spanish dancer caught my eye. It advertised a Flamenco Dinner Show at the El Flamenco Spanish Cabaret upstairs. Naturally, I called to make reservations only to be told they didn't perform midweek in the Spring. Just the same, owner

Estefania Ramirez would be at the theatre around 3:00 PM, if I wanted to meet with her to learn about their world-class flamenco dancers and performances. So, I waited.

Which is how we found the café on the corner. You could wash down tapas with a beer, a glass of wine, or a cup of tea, while painting greenware. They'd even fire it for you. Thus, making your own souvenir. We didn't do this but we should have.

Instead, we settled in at Happy Hour for our final margarita. Actually, that wasn't such a bad idea after all.

Headlight: My Limited Memory:

Early Years of the Fallbrook Vintage Car Club

Dennis Lutz

I am probably the last surviving attendee of the very first Fall Brook Vintage Car Club meeting. I moved to Fallbrook in 1969, just before my junior year in high school. I had purchased a 1956 Chevrolet nomad, which I still own, just prior to moving from Whittier. That year, my brother Dan and I purchased a Model A Ford roadster from a classmate's mother, and we started the restoration which we completed a year later, and he drove it to Fallbrook High School his junior and senior years.

During that time, my dad purchased a 1931 Ford Deluxe Roadster, and a few months later, he purchased a 1936 Ford 3 Window Coupe which the three of us restored.

I do not remember the exact date of the first meeting, but I was either towards the end of my senior year in high school or my first year

at Palomar college. The three of us drove my Nomad over to Paul Stiles's house, where there were maybe 10 to 12 other car enthusiasts. Besides my family, I remember Paul Stiles, Carl Rosenthal, and Bob White were in attendance.

Over the next few meetings discussion followed:

The name Fallbrook was odiously decided, but it was divided into two words Fall Brook, which I think was the original spelling when the

town was first incorporated.

I have a license plate topper I found somewhere in Fallbrook with the spelling of two words. The term "Vintage" was coined by my dad, his belief was that this would open the club up to an assortment of cars that would not be classified as antique or classic, 25 years or older, and my Nomad was only 16 years old.

Paul Stiles was elected president.

Dan Lutz Sr. in his

younger years, had a few cars that he restored or hot rodded including a 1926 Model T, 1934 Victoria and a Roadster, and a 1936 Ford 3-Window Coupe. Marriage and the family came along, and he purchased a new 1956 Bel Air 2 door sport coupe as a family car.

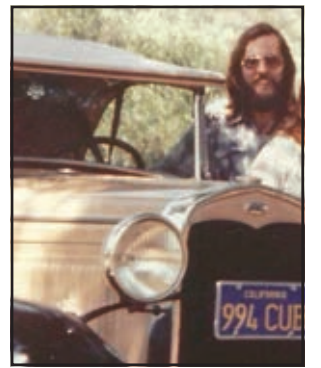
My dad returned to his other lifelong hobby of building model airplanes. He was a craftsman and many of his models were on the cover of model airplane

magazines, along with many articles written about him and the planes he built and flew.

My brother and I sparked the old car flame inside him. He was elected the second FVCC president, and over the next few years he restored two beautiful 1936 Fords, a Roadster, and a Cabriolet. Both achieved national first place awards, along with the prestigious Early V8 Club Dearborn Awards.

In 1983, on his way to work, my dad had a near fatal accident near the Bonsall Bridge. This left him in a wheelchair paralyzed from the waist down. He would pick out a few car shows, or swap meets to attend, and I would drive him to show his cars and visit his friends. He was unable to continue his car restoration hobby and returned to building his world class model airplanes. My dad passed away in 2000 after being confined in a wheelchair for 17 years.

Dan Lutz Jr. drove his Model A Roadster around Fallbrook for years and continued to restore cars,

specializing in Mercedes Benz. Dan passed away in 2002, and I inherited his Model A roadster.

As for me, I drove my Nomad to Fallbrook High School, Palomar College and to San Diego State. I worked in construction and manufacturing before becoming a full-time professor of Industrial Technology at Palomar College, I retired in 2020 after 30 years. I have remained a car hobbyist restoring many 1955-1957 Chevrolets. I now own a 1955 Nomad, and a 1957 Convertible, and my first car, my Nomad. I still own my dad's 1936 roadster.

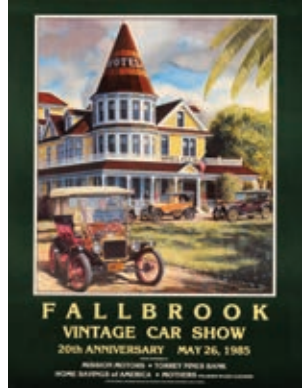

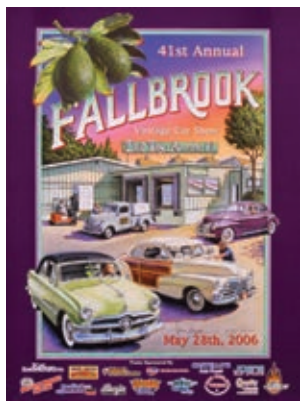
History of the Fallbrook Vintage Car Club

The original Vintage Car Club started as a Model A Ford Club in the late 1950s. At the time, it had approximately 10 members – all Model A owners. The club later moved to the Stiles' Fallbrook Tractor office on East Mission. The original group's only scheduled activity was an annual Memorial Day car show. The annual car show has continued ever since and is the longest-running car show west of the Mississippi and the longest-running charitable event in the history of Fallbrook.

In 1961, the club was expanded, opened to select car brands, and renamed the Fallbrook Car Club. Paul Stiles was the first club President. According to early members, there was no formal election; the Presidency moved from member to member depending on the willingness of a member to take on the responsibilities of the office.

In 1975, the club was renamed the Fallbrook Vintage Car Club after joining the Antique Automobile Club of America as a part of the San Diego Region. Since then the club has become

its own region of the AACA.

The first car poster was issued in 1985. It depicted Carl Rosenberg and his wife Marie driving a 1913 brass radiator Model T Ford leading several antique cars in front of the Ellis Hotel on Main Avenue. Carl drove midget race cars in the 30's and 40's at the Culver City Raceway.

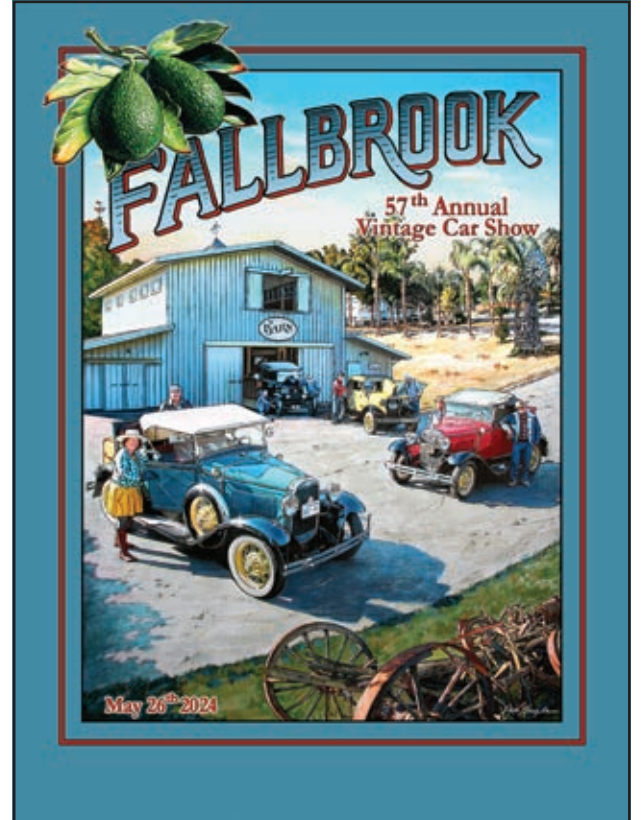
The Fallbrook Historical Society's museum, located at the corner of Hill Street and Rocky Crest, has, in addition to records and displays about the Vintage Car Club, three historic vehicles: a 1923 model T Ford, a 1930 Ford Roadster and a model A Ford driven annually at the Fallbrook Christmas Parade.

The Fallbrook Vintage Car Club today has over 100 active members. The two big events on the club's annual schedule

are the Avocado Festival in April and the Fallbrook Vintage Car Show, which has been held on the Sunday of Memorial Day weekend every year since 1965 and is always free to the public. Proceeds from these two events are routinely donated to deserving local charities throughout the year.

The Car Show Poster for 2024 is the 37th in a limited-edition series. It depicts the founding member's cars in front of the Fallbrook Historical Society.

Each year our posters are available at the Fallbrook Avocado Festival and at our annual Car Show. And now they are available online. Go to www.FallbrookVintageCarClub.org/product-category/posters/ to see them all and visit our online store to buy some.

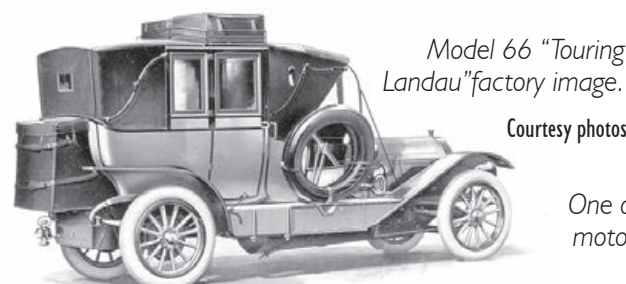
The history of motorhomes

If a "motorhome" is a motorized home on wheels, with such amenities as: bed(s), kitchen, table, seats, toilet, and sometimes even a shower, then motorhomes have been around for over a hundred years.

It is believed that few, if any, motorhomes were built before 1910, likely because most cars and trucks were too small and under-powered. One of the earliest known American motorhomes was custom-built on a 1910 Packard 3-ton truck. It could sleep up to 11 people, had a toilet and an icebox.

Also in 1910 the luxury auto builder Pierce-Arrow (1901-1938) displayed at Madison Square Garden Auto Show a prototype Model 66 "Touring Landau." This show car was a formal limo with a back seat that folded down to form a bed, plus a chamber pot toilet, and a fold down sink with running water. The standard 1910 Pierce-Arrow Landau listed for

\$7,200 and the Touring Landau was a lofty \$8,300; more than ten times the price of a 1910 Ford Model T. It is believed that three Touring Landau cars were built and none are known to survive. Today the Pierce-Arrow Touring Landau is considered the first "factory-built" American small motorhome.

From the mid-teens and into the 1920s many small home-built motorhomes were constructed on the inexpensive Ford Model T car and Model TT truck chassis—and whatever brand they could find. Some of these early motorhomes resembled small wood houses and were sometimes known as a "Car House."

Although the small home-built motorhomes were certainly attention-getters,

they were not as impressive the so-called "land-yachts." One of the most famous was Roland Conklin's 1915 two-story "Gypsy Van." This massive converted bus motorhome weighed 8 tons, and included: Pullman-style folding berths, a full-kitchen, full bathroom with shower, sofa, tables, phonograph, generator, electric lights and even a rooftop covered deck. In the late summer of 1915, the Conklin family drove it from New York to San Francisco—and the Gypsy Van became a national media sensation! It is fair to say that the Conklin's Gypsy Van was the first luxury motorhome and the great grandfather of today's luxury Motor Coaches.

Many more motorhomes were built in the Roaring

1920s, and even during the Great Depression years of the 1930s, but with fuel and tires rationing during WWII, few to none were built.

After the war, especially during the 1950s, factory built motorhomes replaced the home-built and custom motorhomes. In 1958 the first Winnebago was offered and soon the company became the market leader.

Motorhomes have been an important part of automobile history for over a hundred years. From the early home-built specials and one-off customs to today's factory built motorhomes and luxury motor coaches, Americans have truly embraced the idea of a motorized house on wheels.

Last year over 40,000

The early years of automobiles in Southern California

The first known gasoline-powered "horseless carriage" in California was designed and built in Los Angeles. The Erie-Sturgis was designed by engineer James P. Erie and built by Samuel D. Sturgis in his machine shop on West 5th Street. This automobile was conceived two years prior, but it took time to gather the funds to complete the project. Not to alarm horses, it was decided to take the first drive on public roads during the late night of June 30, 1897. With much mechanical difficulty, the car traveled only a little faster than walking speed. After a few more brief drives, the project was abandoned—and only

one example was ever built. The first car in San Bernardino County was a 1899 Haynes-Apperson, built in Kokomo, Indiana. The car arrived on June 26 of that year. C.J. Gaylord was the new owner of this two-cylinder, 7-horsepower motorcar. His early drives on public streets were a sensation and a local newspaper named it "The Stomachless Steed."

The first report of a gasoline-powered vehicle in San Diego County appeared in the February 13, 1900 edition of the San Diego Union newspaper. The owner was D.C. Collier, but the car was simply described as three-wheeler of "French Design" (likely a 1897-99 De Dion-Bouton trike). The earliest known San Diego car photo appears to

show a 1899 Locomobile steam car.

On December 13, 1900, a group of horseless carriage enthusiasts in Los Angeles founded the Automobile Club of Southern California. The club was dedicated to improving roads, posting signs, proposing traffic laws and generally assisting the increasing number of motorists.

No official automobile registration records seem to exist for just Southern California, but by 1900 there were 780 cars registered in all of California. In 1901 there were 1,450 registrations. The following year it was up to 2,290. By 1905 there were 7,890 cars registered. Five years later, in 1910, there were 43,210 cars registered in

California. Today there are over 13 million cars registered in the state—the highest number in the nation.

After a humble start with its first car in 1897, Southern California has gone on to play a major role in shaping American car culture: the first board racetrack (1910 Los Angeles Motordrome); including car chase scenes in films (1910s-); dry lake speed competitions (1931-); Hot Rods and drag racing (late 1940s-); influential car magazines: Hot Rod, Road & Track, Car Craft... (late 1940s-); dune buggies (1960s-); Lowrider car culture (1960s-); "Drifting" competitions (1996-); DJM car collecting and Japanese car shows (2005-) and much more.

Why do Americans drive on the right side of the road and sit on the left side of the car?

In the 1600s, the British colonists in America traveled by horse and wagon on the left side of the road, like in England. With the arrival of Continental Europeans, especially Germans, who

traveled on the right side of the road, the colonists began to travel on the right side of road in some regions. Starting in the early 1800s, American states began to pass laws requiring travel on the right side of the road. By the Civil War (1861-65) all states had mandated driving

on the right side of the road.

When Americans first began to build primitive automobiles in the 1890s, most builders chose to put the driver on the right side of the vehicle (Right Hand Drive - "RHD"). This was likely done to allow the driver to enter

safely from the curb side. With hand-crank cars the driver frequently had to rush between the hand-crank and the driver's seat. Consequently, nearly all pre-1908 American-built cars had the driver sit on the right side of the car.

When Ford introduced

the Model T in 1908, with the steering wheel on the left side (LHD), the advantages of passenger convenience and driving safety became apparent. Perhaps the greatest advantage of LHD was the driver can better judge oncoming traffic when seated

near the center of the road. By the early 1920s all American car manufacturers had abandoned RHD and adopted LHD for their cars. Now you know why Americans drive on the right side of the road and the driver sits on the left side of the car.

The American gas station

For over 100 years American motorists have been able to easily buy gasoline from a convenient gas station near home and far away. Not surprisingly, during the early years of motoring (1900-1910), it was often difficult, but not impossible to buy gasoline.

In 1903, Horatio Nelson Jackson, and his mechanic Sewal Crocker, completed the first trans-continental drive. Jackson drove a 1903 Winton (2-cylinder, 20hp) from San Francisco to New York City. After 63 days, and around 4,000 miles, the Winton had consumed around 800 gallons of gasoline. Although Jackson had great difficulty buying tires for his car, he was usually able to find gasoline for sale, even in small towns, where his Winton was the first horseless carriage in town.

Fortunately for the early motorist, gasoline was already available for stationary "hit-and-miss" engines. Starting before 1900, these simple gasoline engines began to replace animal power, wind power, and steam

engines. Stationary gasoline engines were used to run water pumps, sawmills, generators, and much more. The popularity of these engines encouraged hardware stores, blacksmith shops, and General Stores to sell gasoline, usually sold in steel cans, for easy transport to one's farm.

It is difficult to determine which was the first proper "gas station" in the United States because many technical components needed to be invented first: underground gas tanks (1902), hand-powered gas pumps (1904), gas pumps with sight glass, "spinners" and gallon bells (1910), the large clear glass holding tank for gasoline on top of the pump (early 1920s), and the first electric gas pump (1923).

Between 1903 and 1905 refineries began to build "filling stations" to refill horse-drawn tankers, designed to deliver gasoline to retailers and large customers, but these were not normally open to the general public. Some argue that the first purpose-built gas station was built in St. Louis around 1905. It is known that in 1907 John McLean opened a public drive-through Standard Oil gas station in Seattle, but there was no gas pump, per se. McLean rigged up an elevated gas tank and

a gravity feed hose with valve. Around 1910 some retail establishments began to install simple gas pumps in front of their business – and others quickly followed.

It is believed that two of the first purpose-built, public access gas stations, with actual gas pumps, were opened in 1913. That year Standard Oil opened a drive-through gas station in Columbus, Ohio and Gulf Oil Corp opened one in Pittsburgh, PA.

More purpose-built gas stations quickly popped

up around the country. Over time gas stations also sold tires, auto parts and accessories – and later offered a service bay or two. By the 1930s gas stations were fairly standardized and very common throughout America.

Over the years the small independently-owned gas stations of the 1930s evolved into "full-service" gas stations of the 1940s to 1960s. These were replaced in the 1970s and 1980s with today's national-branded gas stations, with self-service only, and a

prominent convenience store included.

More than a hundred years after the first gas stations were built in America, there is a new problem specifically for electric car owners: finding a compatible fast-charging station when away from home. Similar to the early years of gasoline automobiles, access to charging stations will likely expand to meet the increasing demand. Soon you will be able to either "Gas-Up" or "Charge-Up" anywhere in America.

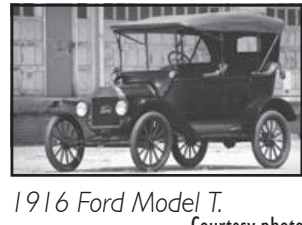

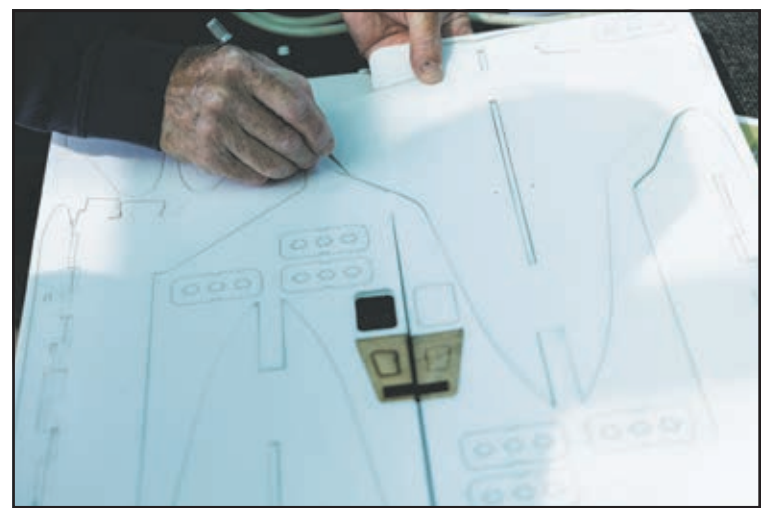

41,000+ Late property tax reminder notices sent to San Diego County homeowners

Paying by e-Check is Fast & Free

SAN DIEGO – San Diego County Treasurer-Tax Collector Dan McAllister sent 41,245 notices May 17 announcing that there is still time to avoid additional penalties if the bills are paid by June 30.

“On July 1, unpaid bills will go into default and receive an additional \$33 redemption fee plus penalties of 1.5% each month,” said McAllister. “That penalty

adds up to a hefty 18% per year but is avoidable if payments are received by the June 30 deadline.” Taxpayers can quickly and easily pay their bills online at <https://www.sdttc.com> at no additional cost if payment is made using the free e-Check option.

Property taxes are due in two installments. The first delinquent date is in December and the second is in April. Each late installment has

already incurred a 10% penalty, plus a \$10 fee if the second installment is late.

The total remaining taxes due is \$180 million, an increase of \$7 million over last year's late payments due. So far, the Treasurer-Tax Collector's office has collected 98.69% of first installments and 97.16% of second installments.

“There is still a small percentage of bills that are not yet paid, and

we want to remind taxpayers that there is time to avoid additional penalties,” McAllister concluded.

The possibility of increased penalties is not the only incentive to pay unpaid taxes by June 30. Under California State law, properties that have been in default for five years may be sold at a tax sale. McAllister encouraged taxpayers to make future payments via the free e-check payment system at www.sdttc.com. Reasons to pay property taxes online:

• The payment system is fast and easy to use.

Fallbrook girls swimmers take league championship

McMahon, Kendall, Dowden, two relay teams individual champions

Fallbrook High School's girls swim team captured the Valley League team league championship while senior Kela Kendall, senior Ava Dowden, junior Maile McMahon, and the Warriors' 200-yard medley relay and 400-yard freestyle relay teams won individual league championships.

Regular-season standings account for half of the formula which determines the final league team championship positions with the other half based on positions at the league meet. Individual league championships are based solely on the results at the league finals.

The league meet was held at Fallbrook High School. The swim preliminaries which determined who advanced to the A, B, and C finals took place April 25, the diving was contested April 26, and the swim finals were held April 27. Schools were allowed up to four swimmers or divers in each individual event, and position points were given for the top 18 marks.

"A pleasant surprise. Going into the season we were not sure how we were going to do," said Fallbrook coach Sean Redmond.

Last year Fallbrook won all seven league dual meets while Ramona had a 6-1 record with the Bulldogs' only loss taking place at Fallbrook. Ramona's girls had a 44-point advantage over Fallbrook in the league meet to give the Bulldogs a share of the league championship at the expense of the Warriors winning it outright.

"Going into the season I knew Ramona was going to be tough, which they were," Redmond said.

Fallbrook and Ramona both took 6-0 league records into their April 19 dual meet at Ramona. Fallbrook won that by a 103-83 score. "It was a close meet," Redmond said.

Redmond and Ramona coach Garrett Glaudini previewed the league meet based on entries. Both predicted Fallbrook to win by about 20 points if all swimmers performed to expectations. "There was not a whole lot of wiggle room," Redmond said.

"The key to the whole meet was going to be in prelims," Redmond said. "We had to do well in prelims."

For individual races the A final competitors automatically have the top six positions regardless of whether a consolation time is faster, and the B final race positions automatically determine seventh through twelfth place even if a swimmer in the C final has a faster time.

"In prelims they swam fantastic and it set everything up for us in finals, so I was pleased with that," Redmond said. "In finals the girls stepped it up even faster."

Fallbrook won the league meet with 549 points. Ramona was second with 450 points. San Pasqual had the third-place score of 325 points.

Five judges scored each dive. The highest score and the lowest score were discarded, and the three middle scores were added together and then multiplied by the dive's degree of difficulty to determine the score for each dive. In 2022 McMahon and Ramona's Piper Williams were freshmen when McMahon won the league championship with 211.25 points on six dives and Williams had the ninth-place score of 118.85 points. Last year Williams won the league meet with 158.65 points

while McMahon had a score of 132.60 for seventh place; Escondido Charter's Jay Bresko accumulated 150.15 points for third place.

McMahon won this year's championship with a score of 209.70 points. "That was exciting to see what she did," Redmond said.

Bresko, who is currently a sophomore, had 208.65 points. "Her last dive, that was just the difference," Redmond said of McMahon.

A back 1 1/2 somersault 1/2 twist has a 2.1 degree of difficulty, so that multiplication gave McMahon the league championship. "That last dive was a new dive for her," Redmond said.

Williams, who is now a junior, was less successful on her more difficult dives. Her score of 176.55 points placed fifth, immediately behind a pair of Fallbrook sophomores. Emylee Turner scored 186.70 points and Dalanie Stroney had 185.00 points. Fallbrook's other diver, freshman Tatum Cahalan, had the eighth-place score of 151.05 points.

Fallbrook's pool has six lanes and the 2024 Valley League had eight teams, so preliminaries were held for

the relay races with the four fastest teams swimming in one final and the other four relay teams participating in the other final. Relay teams in the A final were not guaranteed a position in the top four if a team in the B final had a faster time, but the stronger competition in the A final likely meant faster times for all teams involved. "It was key that we stepped it up in the preliminaries," Redmond said.

Fallbrook's 200-yard medley relay team of junior Liesel Young, senior Ava Dowden, senior Kela Kendall, and senior Ava Papoulias won the final with a time of 1:58.66. "That was our best relay time for the season," Redmond said. "Everything lined up for them that race."

Pacific Ridge had the second-place time of 2:01.68. Ramona was third at 2:02.34.

Fallbrook had three swimmers in the 200-yard freestyle A final. "It showed the depth that we had," Redmond said.

Papoulias was joined in the A final by freshmen Ella Martinez and Ava Bird. "Having two freshmen in the top six was really encouraging,"

Redmond said.

"They went out after it," Redmond said. "They swam extremely well."

Valley Center junior Abigail Martinez won the A final in 1:57.72. "We knew it was going to be a tough race," Redmond said.

Papoulias had the second-place time of 2:04.68, Ella Martinez finished third at 2:06.39, and Bird gave Fallbrook sixth-place points with a time of 2:13.89. Fallbrook's other swimmer in that event, sophomore Sofia Max, took 11th place and had a time of 2:36.84.

Fallbrook also took second and third in the 200-yard individual medley. Valley Center sophomore Kiana Harrington won the race in 2:18.38, Dowden finished in 2:19.51, and Kendall had a time of 2:24.97. "On the girls side that was probably one of the best events, best races there was. It was close," Redmond said.

The individual medley concludes with the freestyle stroke. Last year Harrington competed in the 200-yard freestyle and the 500-yard freestyle at the league meet and finished second in both events. "She was able to catch Ava right there at the end," Redmond said.

A time of 2:48.93 in the B final gave sophomore Linnea Harrington tenth place. The 14th-place time of junior Olivia Searle was 2:57.13.

Redmond and most of the league's other coaches conceded the 50-yard freestyle to Ramona junior Katie Dusseault, who won that event for the third year in a row. The three swimmers who gave Fallbrook points in that event are all freshmen. Emma Votaw took 11th place with a time of 30.17 seconds, Bailee Stevens had a 32.15-second performance for 16th place, and Stephanie Walsh earned 17th place with a swim of 32.29 seconds.

Kendall also finished third in last year's 200-yard individual medley, and she was fourth in the 100-yard butterfly with a time of 1:06.76.

Kendall, Lucia, and Martinez had the second-place time of 1:47.79. Ramona earned third-place points with a time of 1:48.64.

"I thought they did very well," Redmond said. "We knew it was going to be a tough race with Valley Center and Ramona."

The Fallbrook quartet included two freshmen. "They weren't afraid to go up against the other teams," Redmond said.

Young had a time of 1:09.46 in the 100-yard backstroke to finish third. She was 12th in that event last year and had not previously qualified for the A final in any individual event.

"It was exciting and great to see because of the amount of hard work she's done all summer," Redmond said. "She had an opportunity, and she took advantage of it."

Ritchie finished eighth with a time of 1:16.13. Searle had the 11th-place time of 1:20.62. Cahalan completed the C final in 1:26.29 for 16th place.

The breaststroke win gave Dowden league championships in each of her four high school seasons. Although her time of 1:15.95 in the 2021 breaststroke placed her fourth in that event, she was on the winning 200-yard freestyle relay team. Dowden won the 2022 breaststroke championship with a time of 1:10.03. Her winning time in the 2023 breaststroke was 1:12.41.

This year Dowden won the breaststroke in 1:12.15. "She wanted to win the event, but she also wanted to go faster," Redmond said.

Dowden is the youngest of five children, all girls, and all five have swum for the Warriors. Taylor Dowden, who graduated in 2016, holds the school 100-yard breaststroke record which is 1:08.74. Ava Dowden was not successful in breaking her sister's record.

Paris Dowden, who graduated from Fallbrook High School in 2021, won the league breaststroke championship in 2019 and the 100-yard freestyle championship

Her winning time in the butterfly this year was 1:03.08. Mission Hills senior Callan Kamerlander had the second-place time of 1:03.51.

"That was definitely an exciting race and a pleasant surprise. I knew she'd go under 1:05. I knew she was going to have a tough race with Callan," Redmond said. "It really surprised her how fast she went, but I think we knew she was capable of doing that."

Linnea Harrington had the 11th-place time of 1:18.63, sophomore Elsie Ritchie finished 12th at 1:20.78, and Stevens had a time of 1:31.37 for 17th place.

Dusseault also won the 100-yard freestyle for the third consecutive year. Bird was fifth with a time of 59.10 seconds. "You never know what freshmen are going to do," Redmond said. "Ava came in with some promise."

Young finished the B final in 1:00.17 for eighth place and freshman Miranda Minderman finished ninth at 1:07.96. The 18th-place time of 1:12.35 was obtained by sophomore Susanna Kazsuk.

Kiana Harrington won the 500-yard freestyle, but Fallbrook had three swimmers in the A final. Papoulias finished her laps in 5:37.47 for fourth, Martinez had the fifth-place time of 5:39.63, and sophomore Claire Lucia gave Fallbrook sixth-place points with a 5:45.02 performance. Votaw had a time of 6:28.10 for 11th.

Valley Center won the 200-yard freestyle relay race in 1:46.31. Bird,

in 2018. Taylor Dowden won both the breaststroke and the individual medley in both 2015 and 2016, and in 2014 when Fallbrook was in the Avocado West League she was on both winning freestyle relay teams.

"She was able to maintain the family standard for that," Redmond said of Ava Dowden. "That was exciting for her to do that in front of her family and in her home pool."

Valley Center junior Gabrielle Shirley was second in the breaststroke with a time of 1:16.59. Lucia swam the race in 1:18.62 for fourth place.

Her preliminary race was Lucia's first time under 1:20 in the breaststroke. "Over the week she had some nice time drops on that," Redmond said. "That excitement carried over in the finals."

Max was in the B final and had a time of 1:25.17 for tenth place.

The meet concluded with the 400-yard freestyle relay. "The girls and I felt that would be anybody's race between us, Ramona, and Valley Center," Redmond said.

Dowden anchored Fallbrook's quartet. Dusseault was Ramona's fourth swimmer. Abigail Martinez swam the final 100 yards for Valley Center.

"We wanted to give Ava Dowden as much of a lead as possible to be able to hold on to in that event, and that's what they did," Redmond said.

Bird, Ella Martinez, Papoulias, and Dowden won the race in 3:48.64. Ramona finished in 3:49.32. Valley Center had a time of 3:49.42.

Wilson, Skaja/Kendall reach league finals

The Valley League boys tennis tournament took place April 22-23 at San Pasqual High School, and Fallbrook senior Anthony Wilson reached the singles final while the Fallbrook tandem of junior Connor Skaja and sophomore Micah Kendall advanced to the doubles championship match.

All semifinalists qualified for the CIF tournament, and a backdraw with the quarterfinals losers determined the fifth-place singles and doubles players who would continue their season at the CIF competition. Fallbrook's doubles team of sophomore Billy Mathewson and freshman Casey Manion won both of their backdraw matches to take fifth place and the berth in the CIF tournament.

Each school was allowed four singles players and four doubles teams at the league tournament although Fallbrook only had two singles players. Skaja and Kendall played singles during the season's dual matches. "They wanted to play doubles," said Fallbrook coach Bill Lenaway.

Skaja and Kendall also played doubles in last year's league tournament when Fallbrook was in the Avocado League, but they lost in the first round.

Fallbrook's other singles player, sophomore Gunnar Wiessner, lost a 6-0, 6-2 match in the first round to San Pasqual senior Joshua Bredel. Wilson faced Ramona junior Ricky Dinero in the first round. The first set was tied at six games apiece, triggering a tiebreaking game to seven points, and Wilson won the 7-4 tiebreaker. He then defeated Dinero in the 6-4 second set.

"That was a tough match," he said.

Wilson will be attending Yale University when the 2024-25 academic year begins. He attended a week-long orientation session at Yale the week before the league tournament and had not practiced while he was in Connecticut. "Getting back into the game was difficult," he said.

The tournament had 17 doubles teams so all but two of those had first-round byes including the four Fallbrook duos. In a round of 16 match involving four freshmen Escondido partners Diego Garcia and Bryan Pablo defeated the Fallbrook contingent of Adrian Del Razo and Erik Shaver in 6-0 and 6-2 sets. Ramona seniors Avery Baldrige and Noah Furchner eliminated Fallbrook freshmen Ariel Perez and Everett Zietz in a 6-1, 6-1 match. Mathewson and Manion began play with a 6-0, 6-0 win over Ramona freshmen James Hayes and Thomas Wilson. Skaja and Kendall won 6-1 and 6-0 sets against San Pasqual seniors Elian Duarte and Daniel Mejia.

Anthony Wilson faced San Pasqual sophomore Axel Carrillo in the quarterfinals and took a 6-2, 6-0 victory. "I was happy with it," Wilson said. "I was pretty happy that I pulled through and kept on going."

Mathewson and Manion were relegated to the backdraw after a three-set quarterfinals loss to Rancho Buena Vista juniors Darrian Norton and Mohammed Quraishi. Mathewson and Manion

"I'm just impressed," Lenaway said. "I was very happy for them."

Mathewson and Wiessner played doubles in last year's Avocado League tournament and lost their first-round match. Manion ended his first league tournament with fifth place. "I think it was just a really awesome experience," Manion said.

Wilson's semifinal match was against Bredel, who had the fourth seed in the league tournament.

"Being able to go against him was one of the matches I knew was going to be pretty daunting," Wilson said.

A 6-3, 6-0 victory advanced Wilson to the final. Skaja and Kendall reached the doubles final with a 6-3, 6-2 win against Baldrige and Furchner.

Rancho Buena Vista junior Daniel Gonzalez won the singles championship with a 6-0, 6-1 victory at Wilson's expense. "That one was definitely a tough loss," Wilson said.

Gonzalez had the top singles seed in the tournament. Wilson was seeded second. "I think he played up to his seeding," Lenaway said.

Wilson lost in the second round of last year's Avocado League tournament.

The doubles championship was won by the Rancho Buena Vista duo of senior Andrew Cupin and

junior Regis Mariadasan. They defeated Skaja and Kendall in 6-3 and 6-4 sets.

"That was winnable. All games are winnable, but they were a lot better than the teams we were playing before," Kendall said. "It was just a bit of a shock."

Lenaway noted that Cupin and Mariadasan had played doubles throughout the season. "To me that was kind of the difference in that match," Lenaway said.

"We're singles players; we're not doubles players," Skaja said. "They had more experience than us."

Skaja and Kendall improved their performance from their doubles play last year. "We did a lot better, second place compared to out first round," Kendall said.

Warriors win boys swim team league championship

Vance, Reichart, medley relay team also league champions

Regular-season standings account for half of the formula which determines the final league positions for the Valley League swim team championship with the other half based on positions at the league championship meet. Individual league championships are based solely on the results at the league finals. Fallbrook High School's boys won the 2024 league team championship while senior Carson Vance and junior Alex Reichart won individual league championships as did Fallbrook's 200-yard medley relay team.

"It was a big surprise," said Fallbrook coach Bill Richardson. "It was unexpected going into the season."

Last year Fallbrook had a 5-2 record in league dual meets for third place with San Pasqual and Ramona being responsible for the Warriors' losses. Ramona won the league meet as well as the league championship outright, but Fallbrook placed second and San Pasqual was fourth so the Warriors were second in the final league standings. Ramona had a 48-point advantage over the Warriors at the league meet.

This year Fallbrook and Ramona both took 6-0 league dual meet records into their April 19 competition with each other in Ramona. Fallbrook won that meet by a 90-80 score.

A swimmer is allowed to compete in up to four events at a meet and may compete in up to two individual events. A diver may also swim as long as he is not in more than two individual events or four total events. During dual meets each school is allowed three swimmers or divers for each of the nine individual events with position points being given for the five fastest times or highest diving scores while for each of the three relay races up to two quartets per team are scored with

position points given for the first three finishes. If only one school in a dual meet has a diver the diving is not included in the team score although individual divers are scored for CIF qualifying purposes.

The league meet was held at Fallbrook High School. The swim preliminaries which determined who advanced to the A, B, and C finals took place April 25, the diving was contested April 26, and the swim finals were held April 27. Schools were allowed up to four swimmers or divers in each individual event, and position points were given for the top 18 marks. The diving was scored even though Pacific Ridge and Fallbrook were the only schools with male divers.

Fallbrook won the league meet with 491 points. Ramona was second with 387 points. San Pasqual had 363 points for third place.

"We didn't have enough people to catch Fallbrook," said Ramona coach Garrett Glaudini.

"The boys swam well, and it was good to see," Richardson said.

Ramona took first-place points in four of the eight individual swimming events and two of the three relay races. Vance won the 200-yard freestyle and the 500-yard freestyle. Reichart won the 100-yard freestyle with Fallbrook senior Sam Goode taking second place. San Pasqual had the other individual win and Pacific Ridge senior Mason Hood won the diving with a six-dive score of 238 points while Fallbrook senior Jamison Ewig was second with 136.65 points.

Because Fallbrook's pool has only six lanes and the Valley League had eight teams this year preliminaries were held for the relay races with the four fastest quartets swimming in one final and the other four relay teams participating in the other final. For individual races the A final competitors automatically have the top six positions regardless

of whether a consolation time was faster, and the B final race positions automatically determine seventh through twelfth place even if a swimmer in the C final race has a faster time. A relay team in the B final could obtain a position among the top four if the time was faster than one or more of the A quartets.

Vance, Reichart, junior Felix Alcorn, and Goode swam the 200-yard medley relay. Their winning time was 1:45.99. San Pasqual finished second at 1:46.59.

"The boys swam really well," Richardson said. "They all dropped their times."

The 200-yard freestyle race took Vance 1:48.50. "He just swam so well," Richardson said. "He swam a very smart race."

San Pasqual junior Shade Strother was second with a time of 1:50.76. Two Fallbrook sophomores swam in the B final with Jake O'Callaghan posting the tenth-place time of 2:17.07 and John Max finishing in 2:19.32 for 12th place. Had B final swimmers not automatically been given seventh through 12th the 2:13.20 time of sophomore Samuel Stokes would have placed tenth, but Stokes' victory in the C final gave him 13th place.

Vance had a pre-season goal of swimming the 500-yard freestyle in under five minutes. His time at the league finals was 4:57.36. "He finally got the time," Richardson said.

Ramona senior Justin Setterberg became the next finisher 5:04.58 after the starter's gun was fired. "He won it by a long way, had a great race," Richardson said of Vance.

Fallbrook's other three 500-yard swimmers all qualified for the B final. Max won that event in 6:22.33 for seventh place, sophomore Cristian Santana had the eighth-place time of 6:24.82, and junior Ethan Baur took 11th place with a 6:34.13 performance.

Reichart won the 100-yard freestyle in 50.13 seconds, Goode

had a time of 50.38 seconds, and Strother was third at 50.71 seconds. "They both did really well in the 50 and the 100 this year," Richardson said of Reichart and Goode.

Goode was second in the league meet's 50-yard freestyle race with a time of 23.18 seconds. Ramona senior Jordan Isham had a winning time of 22.64 seconds. San Pasqual senior Ali Badrami was third with a time of 23.65 seconds.

Reichart's other individual race at this year's league meet was the 100-yard breaststroke. Ramona junior Brady Bailey won that race in 1:03.48, Reichart finished second and had a time of 1:03.54, and the third-place time of Mission Hills senior Jaeden Tran was 1:03.91.

"Alex had a great race," Richardson said. "The swimmer from Ramona just came in there and outouched him."

Fallbrook junior Milo Pollard was fifth in the 50-yard freestyle with a time of 23.93 seconds and sixth in the 100-yard freestyle with a 53.32-second performance. Fallbrook's other 100-yard freestyle swimmer, senior Kameron Lypps, took 12th place with a time of 1:01.71. Stokes finished the 50-yard freestyle B final in 25.99 seconds for 12th place while a C final time of 27.77 seconds gave sophomore Joshua Avila 17th. Fallbrook placed three 100-yard breaststroke swimmers in the B final with Alcorn winning that race in 1:11.81 for seventh (and the sixth-fastest finals time), sophomore Aiden Lucia taking eighth with a 1:13.84 performance, and Lypps swimming the race in 1:16.67 for 11th place.

All four of Fallbrook's 200-yard individual medley swimmers competed in the B final. "Our boys did well, but almost every school has at least one swimmer who was faster than our guys," Richardson said.

Lucia won the race in 2:31.40, sophomore James Stine finished

in 2:38.22 for ninth place, O'Callaghan finished in 2:38.26 for tenth, and the 12th-place time of 2:44.83 posted by freshman Thomas Calverley was more than two seconds faster than that of the C final winner. "It was very helpful," Richardson said of the position points.

Fallbrook had one swimmer in each final for the 100-yard butterfly. Alcorn took fourth with a time of 59.87 seconds, junior Augustine Paredes finished in 1:03.23 for ninth place, and freshman William Pierseon gave the Warriors 14th-place points with a 1:13.28 time.

The best 100-yard backstroke performance by a Fallbrook swimmer was the 11th-place time of 1:14.72 obtained by sophomore Matthew Williams. The other three Warriors in that race qualified for the C final and finished 16th through 18th with Santana taking 1:18.71, Avila touching the final wall 1:19.62 after the start of the race, and Pierseon finishing in 1:21.15.

Ramona won the 200-yard freestyle relay in 1:31.27. Reichart, Goode, Pollard, and Vance finished in 1:32.84 for second. San Pasqual was third with a time of 1:36.44.

"I wasn't disappointed," Richardson said. "They dropped three seconds from their prelims time. It was the best time of the season. Ramona just happened to be fast."

Pollard, Stokes, Avila, and Alcorn swam the 400-yard freestyle relay in 3:47.53 for third place. "A couple of boys got their best times, so that was good," Richardson said.

Fallbrook and Ramona shared the 2022 league championship; the Bulldogs handed Fallbrook the Warriors' only loss in league dual meet competition while Fallbrook outscored Ramona by 14 points at the league meet. Fallbrook's previous outright boys swim league championship was in 2019.

Warriors win CIF girls lacrosse championship

The first-ever Fallbrook High School girls lacrosse CIF championship was won May 18 at Scripps Ranch High School, where the Warriors defeated Canyon Crest Academy in the CIF Division II final which had a 10-8 score.

"We really worked for it this year," said Fallbrook senior Shea Morgan, who scored seven goals in the championship game.

"This is everything I ever worked for," said Fallbrook senior Myah Pack, who was the Warriors' goalkeeper.

Prior to 2021, the Warriors had not even been in a CIF girls lacrosse playoff game. Debbie Berg took over as the team's head coach in 2020, although that year's coronavirus shutdown limited the season to three games and approximately three weeks including practice.

The 2020-21 CIF seasons were compressed, so multi-sport athletes often had to choose a single sport. Fallbrook had 18 girls in the lacrosse program that year, which is not enough for a junior varsity team (girls lacrosse involves 12 players on the field for each team), and the 2021 Warriors were 5-8 overall including a first-round playoff loss and a 3-3 Valley League record.

"We were very much in the developing stage," Berg said.

In 2022, the Warriors were 4-2 in Valley League competition for second place in the league standings. Fallbrook won a first-round playoff game against Point Loma for the Warriors' first-ever

girls lacrosse postseason victory, lost in the Division II quarterfinal to second-seeded Sage Creek, and finished with a 17-4 overall record to share the San Diego Section's victory lead with Open Division playoffs finalist Scripps Ranch.

The 2023 Warriors finished the regular season with a 16-2 record and were 5-0 in Valley League competition which provided the first league championship in program history. The Warriors had the second seed in the Division II playoffs, which gave Fallbrook a first-round bye. Fallbrook won an 11-7 quarterfinals match against Valley Center, but in the semifinals Our Lady of Peace eliminated the higher-seeded Warriors in a 9-7 game.

The loss to Our Lady of Peace taught the Warriors a lesson not to underestimate an opponent, which was applied in the 2024 final against Canyon Crest. "We did beat them twice," Berg said. "They had every ability to beat us, and we did not take them for granted."

Fallbrook's 2023 roster included only two seniors, and the 2023 Warriors had the largest junior varsity roster in program history (boys lacrosse and girls lacrosse have been CIF San Diego Section sports since 2002). The 2024 Warriors were thus able to apply the lesson learned from last year's playoffs.

During the 2024 regular season, Fallbrook won 15 games and lost four. One of those losses was to Carlsbad in Palomar League play, which gave the Lancers the league championship. "They were a very,

very good team in our league," Berg said.

Carlsbad won the CIF Division I championship to give the Lancers an 18-4 overall record. Fallbrook took second in the final league standings at 5-1.

The CIF playoff seeding and selection meeting May 4 gave Fallbrook the second seed in the Division II playoffs, so the Warriors had a first-round bye. Canyon Crest was seeded fifth, and the Ravens defeated 12th-seeded Valhalla by a 17-4 score in the first round.

Fallbrook hosted Westview in a May 10 quarterfinal and won that 16-9 game. Canyon Crest played at fourth-seeded Point Loma and took a 12-9 win over the Pointers in that quarterfinal.

Pacific Ridge, which was seeded sixth, also defeated a higher-seeded team in the quarterfinals. The Firebirds faced third-seeded Sage Creek and won by a 15-11 score. That gave Pacific Ridge a May 15 semi final in Fallbrook which ended as a 14-12 Warrior's triumph.

"That's how you get here," Berg said of the Warriors' first championship game appearance. "You have to win semis to get here."

During the regular season University City defeated Fallbrook, Canyon Crest, and Point Loma. The Centurions were 8-0 in Eastern League play and 15-3 during the regular season. All three of those losses were to Division I schools, and the Centurions had the top seed in the Division II playoffs, but Canyon Crest once again defeated a higher-seeded team and advanced to the championship game against Fallbrook with a 12-8 victory over University City.

The two regular-season games between Fallbrook and Canyon Crest were a 14-12 Warriors home triumph March 19 in pre-league play and a 14-10 Fallbrook league win April 16 at Canyon Crest. The Warriors began scoring in the CIF final 28 seconds into the game when junior Olivia Searle placed a shot into the net.

"It was really important because it kind of set the tone for the game," Searle said.

"That first goal was awesome. I think it brought us that energy that we wanted," Morgan said. "She has grown so much as a player."

Someone other than Morgan

scoring the Warriors' first goal sent a message that shutting down Fallbrook's primary attacker wouldn't necessarily bring success. "Set the tone that everything is going to be spread around and every single person is a threat to score," Berg said.

"It's something we've worked on all year," Berg said. "We had many weapons on our team. Shut down one, somebody else is open. Double-team one, somebody else is open."

Morgan scored to give Fallbrook a 2-0 lead 40 seconds into the game.

The Warriors scored on both of their first two shots. The first Canyon Crest shot occurred with 9:45 left in the first period. Pack saved that attempt. "It sets up the tone for the game that you're going to be making big stops," Pack said.

With 8:17 left in the first period Canyon Crest senior Lake Mallery scored the Ravens' first goal of the game. Ravens junior Petra Kozakowski tied the game with a goal 2:01 before time expired in the first quarter.

The momentum shifted to Canyon Crest, whose goal 1:19 into the second period gave the Ravens a 3-2 lead. Morgan tied the game with a goal 3:49 before the halftime whistle sounded, and with 22 seconds left in the half she scored again to give the Warriors a 4-3 halftime lead.

"I knew that I had to change things up," Morgan said.

Mallery created a 4-4 tie by scoring 18 seconds into the third period. Morgan countered with a pair of goals 46 seconds and 90 seconds into the quarter. Kozakowski placed a shot into the net to make the score 6-5 with 3:01 left in the period and, 10 seconds later, Mallery tied the game with a score.

Morgan scored with 2:26 left in the quarter for a 7-6 Warriors advantage, but Kozakowski scored in the final second of the third period to make the score 7-7 entering the fourth quarter.

"Most intense game I ever had," Pack said.

"Coming into that last quarter I knew I needed to bring something," Morgan said.

That included a presence which would allow other players to handle the scoring. "I wanted to spread out and use my teammates," Morgan said.

The quarters were 12 minutes long. With 9:53 left in the fourth period senior Jasmine Uresti scored a goal which put the Warriors ahead for the rest of the game.

"I'm glad to make my last year one of the best years," Uresti said.

Fallbrook's 2024 varsity roster included two Morgan sisters who combined for a total of eight goals in the championship game. The goal by sophomore Ashlyn Morgan was scored with 8:49 remaining. Shea Morgan created the game's first three-goal lead by scoring with 8:38 left on the clock.

Kozakowski changed the score from 10-7 to 10-8 by placing a shot into the net with 7:06 remaining. "We played every single minute of that game," Berg said.

The defensive effort was complemented by Ashlyn Morgan obtaining the ball late in the game and avoiding defenders to run time off the clock. "At that moment it was just about keeping our possession," she said.

A final Ravens shot was blocked with 33 seconds remaining.

"I'm really glad how well we all worked together," Searle said.

"I'm really proud of my team," Shea Morgan said. "So glad not to lose at the very end."

Lacrosse does not have CIF state or regional playoffs. Fallbrook finished the season with an 18-4 record as well as the CIF championship.

Berg is also Fallbrook's field hockey coach. She piloted the Warriors to the 2019 CIF Division II championship in that sport, so the CIF lacrosse championship makes her the third Fallbrook coach to win CIF team championships with two different programs.

Boys cross country had Large School and Small School championship classifications in 1974 when Walt Parry coached the Warriors who won the Small School championship, and Parry coached the girls cross country team which won Class 1A CIF championships in both 1978 and 1979.

In 2012, the boys swim team coached by Bill Richardson won the CIF Division I team championship, and Richardson's boys water polo team won the CIF Division II championship in 2014.

"I'm actually just very blessed," Berg said. "I've enjoyed the ride."

Vallecitos requests waiver for Trustee Area 1 vacancy

The Vallecitos School District seat for Trustee Area 1 is currently vacant, and the school district board is requesting a waiver of the 60-day deadline to fill that vacant seat.

The board's 3-0 vote May 14, with Ritsa Chanthabandith in Europe, authorized the submission of a waiver request to the State Board of Education. The waiver, which is expected to be granted, will allow the school district to fill the vacant seat by appointment rather than by an election.

"We're still looking for one more board member," said Vallecitos School District superintendent Meliton Sanchez.

Chris Howells, who had been the board member for Trustee Area 1, has moved out of California. Howells submitted his resignation effective February 12. The February 13 Vallecitos School District board meeting included a 3-0 vote to approve the provisional appointment process for the vacancy.

Section 5091 of the California Education Code stipulates that if the vacancy is not filled within 60 days the County Office of Education superintendent shall call

an election to be held within 130 days after the election is ordered unless the school district requests a waiver of that deadline. The waiver is intended for situations such as a lack of applicants rather than for a deadlock in which no applicant receives the necessary board majority to be appointed. Calling an election when no residents previously applied could also create the possibility of no candidates filing for that election.

On April 9 Chanthabandith was appointed to fill the vacancy for the Trustee Area 5 seat. Her trip to Europe which included the date of the May board meeting had been planned prior to that appointment.

"We are now looking for a representative to serve Trustee Area 1," Sanchez said.

Trustee Area 1 is in the north central part of the district and is on both sides of Interstate 15. An applicant must be a registered voter in that trustee area. Applications to fill the vacancy are available in the Vallecitos School District office.

Because the term of the seat is from December 2022 to December 2026, the seat will be subject to election for a two-year term in November 2024 although the appointed incumbent may file for that two-year term if he or she desires.

goods. Children tossed footballs and baseballs on the fields while their parents relaxed in their chairs under the shady oak trees.

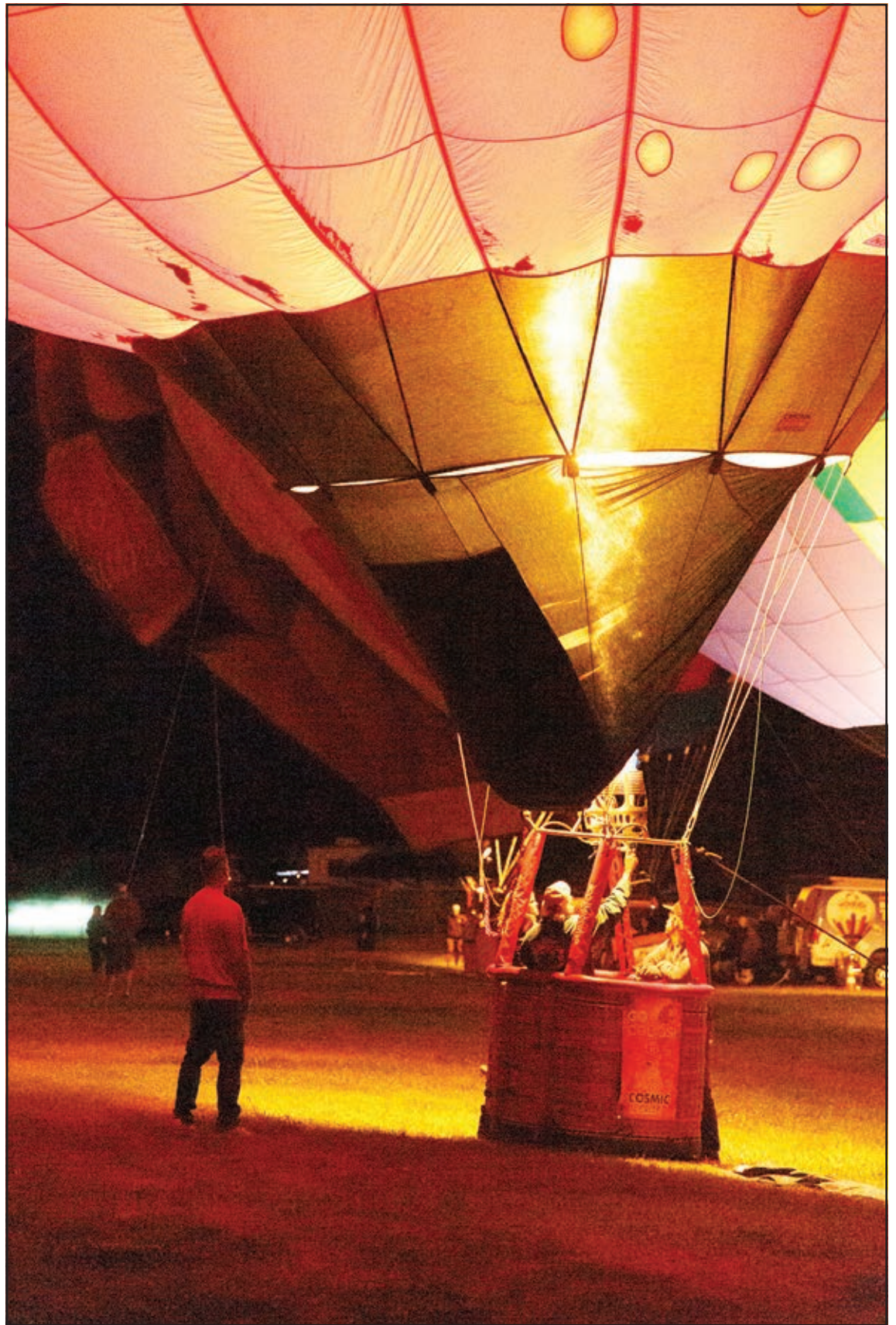
Nonprofit agencies provided guests with information and guidance to make their days even more enjoyable.

Dr. Wooten honored with California Public Health Award

The California Department of Public Health honored County Public Health Officer Dr. Wilma J. Wooten with its highest recognition, the Beverlee A. Myers Award for Excellence in Public Health.

The Beverlee A. Myers award is presented annually for outstanding leadership and dedication to all aspects of public health.

During the award ceremony in Sacramento, CDPH leadership honored Dr. Wooten's 23 years of County service, highlighting her leadership during the COVID-19 pandemic.

"The COVID adversity did not just build her character. It revealed her character," said Susan Fanelli, Chief Deputy Director at CDPH,

during the award presentation. "Throughout her life, Dr. Wooten has broken barriers and has served as a role model for young people, especially Black American girls who wish to pursue a career in medicine and science."

Dr. Wooten joined the County of San Diego in 2001 and was named Public Health Officer in 2007.

She was born in rural Alabama and was the first person in her family to go to college. She graduated from Spelman College in Atlanta with a degree in biology then earned her Master of Public Health from University of North Carolina-Chapel Hill, where she also completed her doctorate at the school of medicine.

In her remarks, Dr. Wooten highlighted the support from her Public Health Services team and fellow health officers throughout the state. She was dedicated to

following the American Public Health Association's "10 Essential Public Health Services" and shared some of the "truths" that have served her well.

"Make sure to socialize what you think is a 'great idea' with those you think are supportive, as well as with those reluctant, opposed or impacted by your important policy, practice, or program," she said. "And don't agonize over things that you cannot change."

The Beverlee A. Meyers award was established in 1993 in honor of the late Beverlee A. Myers and her 25-year career with CDPH.

Dr. Wilma J. Wooten is recognized with the Beverlee A. Myers award for outstanding leadership and dedication to all aspects of public health.

County confirms 3rd measles case of 2024

San Diego County public health officials have confirmed the third case of measles in the region this year in a 13-month-old resident who had recently traveled overseas.

The county previously confirmed two other cases in the region this year. None of the three cases are linked, but all are associated with international travel. Before 2024, the last confirmed measles case in the county was in 2019.

The unimmunized infant may have exposed others at the following times and locations:

Children's Primary Care

Medical Group El Cajon, 844 Jackman St., Sunday, May 12, from 9:10 a.m. to noon.

Rady Children's Emergency Department, 3020 Children's Way, 1st Floor in San Diego, Monday, May 13, from 10:30 a.m. to 12:45 p.m.

County epidemiologists are working with Children's Primary Care Medical Group El Cajon and Rady Children's Hospital to identify and follow up with patients and staff to determine if those possibly exposed at these locations have been vaccinated. They will also evaluate their potential for developing measles.

"Measles is a very contagious disease that can be spread easily by coughing, sneezing or being in the same room with an infected

person," Dr. Wilma J. Wooten, county public health officer, said. "Anyone who was at any of the specific locations and at the dates and times listed above should watch for symptoms and call their health care provider if they show any signs of the disease."

People with symptoms are asked to call their doctor's office in advance, rather than visit an office directly, so that infection control measures may be taken to prevent exposure to others.

Measles develops seven to 21 days after exposure. Early symptoms include fever, cough, runny nose and red eyes. A distinctive red rash usually appears one to four days after early symptoms start.

A person is considered

contagious four days before and four days after the rash appears. The rash typically begins on the face and head, then proceeds downward and outward to the hands and feet. It fades in the same order it began, from head to feet.

"The best way to prevent measles is by getting the measles vaccine," Wooten said. "With measles outbreaks occurring in several countries, it is very important that all international travelers get vaccinated. Infants between 6 and 12 months of age who travel should get one dose, and travelers over 12 months of age should get two doses at least four weeks apart."

Complications from measles are more common in children

younger than 5 years old and adults 20 years and older. Complications can include diarrhea, ear infections and pneumonia. Death can occur from severe complications and the risk is higher among younger children and adults. There is no treatment for measles. Bed rest, fluids and fever control are recommended. People with complications may need treatment for their specific problems.

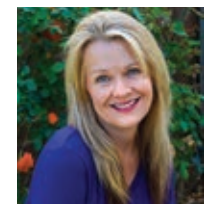
