#### Free cookbooks for new subscribers

Bell leads 'Village News Holiday Cookbook' team

FALLBROOK - Julie Reeder, publisher of the Village News, announced April 20 that all new subscribers to The Village News will receive a free Holiday Cookbook compiled by Judith Bell, long time food editor of the newspaper.

"It's going to be a true keepsake, "Reeder said.

"This cookbook is something Julie Reeder and I have discussed for years. We are both very excited to bring it to our subscribers in time for the holidays."

Bell will write "The Village News Holiday Cookbook" and coordinate production of it with the Village News staff. With more than 180 pages and 240 recipes, there'll be something for everyone within the cookbook, Reeder noted.

Current subscribers will be receiving a special mailing so that they may also receive a free cookbook.

Fallbrook's 36th annual Avocado Festival is on Sunday April 23, 9 a.m. to 5 p.m. on Main Avenue, between Hawthorne and Fallbrook streets. "It may attract many people who love avocados and want to dress as an avocado," laughed Lila Hargrove, CEO and event coordinator.

"You might see 'avocados' strolling down Main Avenue since one of the two new contests is Dress In Your Best Avocado Attire," said Hargrove. "Participants will compete in four categories, ages 4 and under, 5-11, 12-17, and 18+ (adults). They'll be judged at the Fallbrook Chamber of Commerce information booth at 1 p.m."

Avocado Holding is the other new contest. Test your strength and endurance by holding a bag of avocados with a straight arm for as long as you can. Registration is limited and there will be two time slots. The first 10 people registering at 10 a.m. will compete at 10:15 a.m. The first 10 who register at noon will compete at 12:30 p.m. Come to the Main Stage to register and compete at South Main Avenue and East College Street at Scrappy's Tire and Auto Repair.

"We'll have an Artisan Walk on Alvarado Street. It's a favorite of mine where you can grab some great unique gifts for yourself and others," said Hargrove. "Vendors

will be selling jams, jewelry, glass and wood art, soaps, candles, fine art, and baked goods. Many will feature avocado themed items."

Other contests this year will be for the Best Guacamole, "Best Dressed Avocado" (decorate a real one), and "Little Mr. and Miss Avocado." See the chamber's website or call the chamber to learn the rules and if there are age categories for the competitions.

Fallbrook voters in Area 1 of the Fallbrook Union High School district will be able to vote in the next several months for a vacancy on the school board.

Courtney Hilborn won election last November and was seated in December, but resigned in January after moving out of the district.

The board made a provisional appointment of Jim Dooley at its Feb. 13 board meeting, but conservative parents were not pleased, contending the female applicant they endorsed would better represent the district. They noted that Hilborn and Paul Christian comprised a conservative slate that was broken with the appointment of Dooley.

Paul Gothold, County

Superintendent of Schools, notified petitioners Lindsay Jones and Judy Willis on April 13 that they had submitted sufficient signatures to discharge Dooley's appointment and have voters in Area 1 participate in a special election. A map of the area boundaries can be found at https://www.fuhsd.net/district/ resources-board-of-trustees.

The board currently has three men serving: President Eddie Jones, Vice President Oscar Caralampio, and Paul Christensen. The board also has a vacancy in Area 2 since the November election when the area election policy was established. The area covers the southern portion of Camp Pendleton; no one ran for the seat in November, and no one has sought an appointment to it.

### If the Earth is warming, why all the snow?

FALLBROOK – The Fallbrook Climate Action Team (FCAT) will present Jonathan Cole, Mira Costa College Professor Emeritus, to speak about the effect of Climate Change on the water cycle as well coa cold woother not come April 25 at 6:30 p.m. Cole has been a professor for 38 years and wrote the curriculum on climate change for the college. Last year he spoke about hot spots to FCAT; his presentation was wellreceived, with many attendees commenting on his expertise and clear communication style.

This winter was one of the coldest and wettest in recent decades, with a near-record snowpack in the Sierra Nevada. How does this square with rising global temperatures? Cole will discuss the impacts of global warming on rain and snow, and why extreme swings in precipitation and temperature patterns may become more common as the Earth's temperature continues to rise.

FCAT is an all-volunteer group that presents monthly (except December) presentations about climate change and mitigation, usually on the last Tuesday of the month on Zoom. To receive the Zoom link, sign up for the group's eblast at <u>https://</u>fallbrookclimateactionteam.org/.







"I'll even share an easy recipe for homemade English muffins, 'Bell said.

Reeder and Bell agreed that the free Holiday Cookbook is "one of the most exciting and worthwhile endeavors that celebrates the 25year old newspaper."

Bell earned her undergraduate degree at Iowa State University with a double major in journalism/ food and nutrition. She did her master's in nutrition at the University of New Haven's Los Angeles campus.

The San Diego County Office of Education and the Registrar of Voters will work together to order the special election in accordance with state Education Code, a spokesperson said.

A date has not yet been set and the timing of the election is determined by law. The exact date of the special election will depend on a variety of factors, including the date of the next regularly scheduled election.

"If the petition is determined to be legally sufficient by the county superintendent of schools, the provisional appointment is terminated, and the county superintendent of schools shall order a special election to be conducted not less than 88, nor

more than 125, days following the order of the election," the code states. However, it also states that the election could be extended to 180 days after the issuance of the order if that election could be consolidated with a regularly scheduled election.

Once the election date is determined, the filing period and other details for candidates will be set. Only residents living in Area 1 are eligible to be on the ballot.

Asked if he intended to seek election, Dooley said, "Too early to say. I won't decide before the filing date."

Dooley, who is retired, placed second in the November election to Hilborn. He received 46% of the votes in the two-person race.

The ROV has estimated that the election could cost FUHSD between \$100,000 and \$225,000.

the MC, but it is a lot of fun," said past and likely 2023 master of ceremonies Eric Ortega, who is a member of the Pala Tribal Council and is the assistant station manager for Pala Rez Radio.

Cupa Days will include cultural entertainment, native crafts, and peon. Peon is a game played by two teams of four men apiece along with a referee. One team at each time has four white bones and four black bones along with a blanket which is used to conceal the bones. The other side guesses which hand the bone is in (a string is attached to a hole in the bone and is wrapped around the wrist so that the player cannot change hands after the guess).

The side with the bones also sings songs to distract the other team. The referee awards tally sticks for correct guesses, and the game ends when one side has all 15 tally sticks. The game was often part of annual festivities, and peon was common to the Kumeyaay, Luiseno, and Cupa cultures.

The Cupeno had a village in what is now the Warner Springs area called Cupa - the village had been spelled as Kupa before California became part of the United States. In May 1903, the Cupeno were evicted from Cupa and were relocated to the Pala Indian Reservation approximately 30 miles away. Cupa Days is held in May because of the anniversary of the relocation.

"It's not a festival because it's still part of a memorial," Ortega said.

Ortega's grandfather attended the Carlisle Indian Industrial

School in Pennsylvania. Sherman Indian High School was once called the Sherman Institute and was a boarding school. Boarding schools were an attempt to assimilate Indians into American culture.

"A lot of students were sent away to schools, and they weren't allowed to speak their language," Ortega said.

"They were taught English, but they weren't taught advanced English," Ortega said. "They (the non-Indians) wanted them to be industrial workers, so they were taught basic English."

The boarding schools also split up siblings, and family members were not allowed to visit, so they were also at the expense of the Native American family structure.

Most non-Indians think of Carlisle Indian School not as an element to destroy American Indian culture and create industrial workers but as a football powerhouse where Jim Thorpe played and where Pop Warner coached.

American political leaders eventually relented on the assault on Native American culture and customs. "The whole idea of the cultural center was to preserve the language and the culture," Ortega said.

The Pala Tribe began building the Cupa Cultural Center in 1970. At the time the reservation's largest source of income was a quarry on tribal land, but no quarry revenues were used for the Cupa Cultural Center and the facility was also built without any public money or private grants. Reservation members provided the donations. The Cupa Cultural Center was completed in 1974.

When they completed it that May, they had a grand opening and they had the first Cupa Days, Ortega said.

Prior to the April 2001 opening

of Pala Casino, the Tribe used Cupa Days to fund cultural activities. "Cupa Days was the event we used to raise money," Ortega said.

Native American tribes historically visited other lands both for trading and for marriage purposes, so the participation of peoples other than the Cupeno and the Luiseno (Pala itself was historically Luiseno land) allows other tribes to share their culture with the Pala Tribe.

A government health order is not part of the California Penal Code and is thus civil regulatory rather than criminal prohibitory, which means that a sovereign Indian reservation may but is not obliged to comply. The Pala Indian Reservation thus wasn't subject to coronavirus restrictions on public gatherings, so the May 2021 Cupa Days was held in-house after not being held at all in 2020.

"In 2022 when we had it, it was actually the first Indian event in Southern California," Ortega said.

Some limitations were part of the 2022 Cupa Days. "This year we'll be kind of wide open again," Ortega said.

Representatives of tribes from throughout California and Arizona will perform during this year's Cupa Days. That includes the Inter-Tribal Bird Singers led by Pala tribal member Wayne Nelson. "That's sharing our culture,' Ortega said.

The performances will include dancers as well as singers. "We're trying to show each other and everybody else that we're still here," Ortega said.



### Consultants meet with groups about superintendent replacement

Consultants helping the board

find a new superintendent for

the Fallbrook Union Elementary School District have been busy meeting with school and district staff, as well as community members, for the past two weeks. They are on a tight timeline with the goal of having the new leader of the area's largest employer on board by July 1.

At a town hall meeting on April

12, about 35 people attended a casual meeting to discuss what the community wanted to see in a new superintendent. The event and an online survey have been promoted on the district's web page. The deadline to complete the survey was April 15.

The consultants, Rich Chavez and Peggy Lynch of Leadership Associates, made a brief presentation and welcomed questions at the town hall meeting. There were questions and discussion on topics like the district's dual immersion program, the need to seek input from the Latino community, and if the new superintendent would receive the same salary as former superintendent Dr. Candace Singh. She represented one of the smallest districts in the county but earned one of the highest salaries.

Chavez said the salary amount was up to the school board, but that he would be giving the members a report of superintendent salaries throughout the state and he was sure the new person would start much lower than Singh's \$387,433.76 salary after 11 years with the district.

In the last two weeks, Chavez and Lynch said they met with school staff, the district cabinet and principals, union representatives, civic groups, faith-based leaders, and many others to learn about the community concerns and what they wanted to see in the new hire - in order to help identify the top selections for the school board to consider.

They also placed an ad in EdCal, a web page advertising platform, and expect multiple applicants by the April 21 deadline. The consultants said they have begun making comprehensive reference and background checks on the applicants.

On May 11 at 5 p.m., the consultants will give a report to the board, which is tasked to select candidates to be interviewed. This will be done in a closed session that should last about three hours.

Then on May 20, the board is expected to meet all day in closed session to interview the finalists and select the new superintendent. If that schedule is true as projected, the board is expected to approve the superintendent's contract at its regular board meeting on June 5 - making the July 1 deadline as a start date.

Leadership Associates was awarded a \$25,500 contract to help the board select Singh's replacement at the March 13 board meeting.

Board members Dr. Stacey McRae, president, Suzanne Lundin, Mary McBride, Ricardo Favela and Diane Sebalj have said the selection of the right superintendent is the most important decision they will make as trustees.



### RWQCB issues new discharge order for SONGS decommissioning

Southern California Edison, which is the majority owner of the former San Onofre Nuclear Generating Station, plans to terminate discharges from SONGS into the Pacific Ocean by 2028 and the decommissioning is expected to be complete by 2051. Although ocean water is no longer needed for power plant cooling purposes, the continued intake of ocean water is needed for the ongoing operation of saltwater pumps to discharge wastewater from the decommissioning activities through the Unit 2 ocean outfall.

On April 12, the Regional Water Quality Control Board

unanimously voted to replace the previous waste discharge order with a new National Pollutant Discharge Elimination System permit.

SONGS began operation in 1968. By April 1987, San Onofre was producing 17.4 terawatts of electricity. San Onofre ceased producing power in 2013 when Unit 2 and Unit 3 were shut down.



Although the continued intake of ocean water is needed for the ongoing operation of saltwater pumps to discharge wastewater from the decommissioning activities, SCE has reduced intake flows by approximately 99%.

The new waste discharge order limits the intake of seawater to 30 million gallons per day (mgd) while limiting combined seawater and wastewater stream flows discharged back to the Pacific Ocean through the Unit 2 ocean outfall to 42.252 mgd, which is a reduction from the previous quantity of 56.3 mgd. The draft revised waste discharge order was released for public review and comment Feb. 2. The public comment period closed March 6. SCE did not submit a comment letter, but eight comment letters were received and reviewed. Seven of those comment letters supported adoption of the tentative order while one requested changes to the Monitoring and Reporting Program. The change requests were incorporated into the final waste discharge order.

The monitoring frequency was changed from semi-annually to monthly to characterize the discharge and its impacts to the receiving water where there is heavy recreational use. Ocean sampling for fecal indicator bacteria to monitor for accumulation of toxicants in the marine environment, especially for nearshore areas with high recreational use at San Onofre State Beach, will be required.

Ocean sampling for toxicity and heavy metals to monitor for accumulation of toxicants in the marine environment, especially for nearshore areas with high recreational use at San Onofre State Beach, will also be required. Nearshore or onshore sediment sampling will be added for accumulated buildup of metals and toxicants of concern to ensure the safety of nearby recreational uses.

The new waste discharge order also adds effluent limitations for nickel and removes effluent limitations for arsenic, hexavalent chromium, and antimony. Monitoring will still be required for arsenic, hexavalent chromium, and antimony to determine if effluent limitations are required in the future.



### Temecula Valley Hospital awarded \$1 million grant from city of Temecula toward mental health

TEMECULA – Temecula Valley Hospital was recently awarded a grant by the city of Temecula totaling \$1 million toward mental health. The funding agreement, signed and executed by City Manager Aaron Adams, was based on the city council's direction in late 2022 to grant the hospital \$1 million from the community reinvestment grant program.

The city council established the program to provide grants to organizations providing behavioral health and social services to persons living or working in Temecula.

"This funding will assist

veterans, active-duty military, first responders, youth and homeless individuals in need of behavioral or mental health services, that reside or work in the city of Temecula in furtherance of the health, safety and general welfare of the community," Adams said. Darlene Wetton, CEO of

TVH in providing behavioral

health services to assist at-risk

Temecula Valley Hospital, shared that she is honored to be a recipient of the grant funds.

"There is a significant shortage of available services to support the behavioral health needs of the community's at-risk populations," Wetton said. "Sadly, the Riverside University Health System – Public Health reports a suicide rate of 11.8 per 100,000 in Riverside County which can be compared to a 10.5 suicide rate per 100,000 in California between 2018 and 2020.

"The funds provided shall be used to build awareness through community education, and most importantly, introduce behavioral health programs that will be critical in servicing first responders, active-duty military and our honored veterans. This program, hosted at the hospital, will be led by trained social worker, Kelly Felton," she said. Felton is a licensed clinical social worker who earned a master's degree in social work from the University of Southern California and a bachelor's degree in sociology from Fort Hays State University. She is trained in crisis management and stabilization, conflict resolution, investigations, program development and has facilitated prevention and intervention community groups and worked in community outreach programs.

"I am excited and honored to embark on this incredible opportunity for our hospital, in partnership with the city of Temecula, to provide a muchneeded, elevated level of care for our community," Felton said.

Felton said she is committed and passionate about working toward equitable access to behavioral health services across all communities; utilizing best practices to make a positive impact and supporting and enhancing individual and community health.


### Parkinson's Group To Learn About Robotic Devices

FALLBROOK – North County Parkinson's Support Group invites anyone interested to join their monthly meeting, Friday April 28, 10 a.m. to noon at the Fallbrook Regional Health and Wellness Center, 1636 E. Mission Road.

Guest speaker Doctor Martin Nguyen's topic will be "Rise Physical Therapy/Hybrid Assistive Limb (HAL)." He is certified in Applied Functional Science and he has been practicing physical therapy for six years.

Nguyen has worked in outpatient orthopedics and sports medicine his entire career. He is the director of community relations for Revolution In Self Evolution (RISE) Healthcare Group. His role is to help build relationships and partnerships with various community organizations across San Diego.

HAL is a robotic device, a one of a kind blend of technology and rehabilitation used to read a patient's intent for movement. It was developed by the Japanesebased company, Cyberdyne. HAL is FDA-approved, designed to help improve/regenerate the function of the wearers, those suffering from



The device detects signals from the brain towards the target muscle tissue at a skin level, then allows the device to provide assistance towards the desired movement. It ultimately improves the patient's own ability to move the limb body part. This is what separates the HAL from other exoskeletons in the current market, in the United States.

RISE physical therapy was born from a simple philosophy: "It doesn't matter who you are or what you do, everyone deserves the best treatment possible." It is a journey of strengthening the mind, body and spirit. Sessions are one-on-one with the provider and or the resident.

In addition to the speaker presentation, breakout groups held for a time of sharing, coffee and refreshments will follow the program.

Meetings are held in support of persons with Parkinson's disease, care partners and people interested in improving the world of those affected by Parkinson's disease, on the fourth Friday of every month.



### Blood draw reveals many secrets of the body

Medical patients have seen at least a few of the common categories that can be marked on a lab order – white blood cell count, red blood cell count, cholesterol, blood glucose (sugar), etc.

What you may not know is that in the short amount of time it takes to prick the arm and fill the allotted vials, each person's blood provides a detailed, personalized health map for a doctor to review. It can reveal secrets taking place in the body that the patient is unaware of.


Blood contains genetic information, and glimpses into the person's lifestyle. The testing of blood can reveal precautionary flags that can be vital to address in regards to an individual's longterm health picture.

These results provide a perfect 'snippet in time.' A blood draw, in addition to any other laboratory tests, "combined with a careful review of patient history and status [allows for] a diagnosis," explained Carlo Ledesma, MS, MLS(ASCP) SH, DLM, QLS, MT (AMT), who serves as Director of Phlebotomy and Medical Lab Technology at Rose State College. Ledesma is certified as a specialist in hematology, as an international medical technologist, and holds a qualification in lab safety. Ledesma said, "The common blood tests like blood count and metabolic panels tell a clinician or a provider what the metabolic status is of a patient or if there are any physiologic disturbances."

It's all on a case-by-case basis though. "In most blood results, one usually sees a column or a flag if it is high/low or if there needs to be a clinically actionable item (i.e. critical results); however when someone sees a 'low' or 'high' flag, that doesn't necessarily mean an abnormal condition at that moment your blood was drawn." It's human nature to see a red flag on a lab result and panic - but what's reassuring is that it could "also reflect a normal physiologic state or a patient 'normal.' To address results from blood tests requires a careful review of a patient's medical history or addressing factors that may contribute to the results being an outlier."

It is important to stay proactive with getting the required lab tests a doctor orders, so they know what "normal" is vs. a cautionary result in a person.

Ledesma said an annual blood draw is always a wise idea and noted, "It is always a good idea to have an annual check to look at your overall health. Keeping track of your blood results and discussing them with your

provider will help you understand any significant changes that are happening with your body."

As we know, habits involving sleep, food, stress, and more play a constant role in shifting our state of health. If an annual blood draw shows significant change to the prior, he said, "A significant change in a lifestyle may be reflected there and can be addressed. These common blood tests are also what emergency physicians look at in cases where an acute change happens that may disrupt normal physiologic processes (i.e. poisoning, acute blood loss)."

With a plethora of books on the topic of 'eating for your blood type,' one wonders if certain tendencies are really associated with each blood type. Ledesma said that "There are a lot of studies surrounding blood type and disease associations, but we first have to think that correlation doesn't mean causation."

He continued on, "In the age of molecular diagnostics, and our increased understanding of the molecular basis of disease, blood type associations with disorders

have been trumped by more sophisticated tests."

His approach, when looking at blood studies and how it connects with disease associations, as a trained scientist is, "'I always ask the question... Now what? How can we address these then? We can't change someone's or the entire population's blood type. What do we do with these types of information?""

In regards to current blood studies, "It begs to ask the question that we need to understand diseases more and far beyond that information so we could understand what's next... diagnostics, therapeutics, management... and prevention of disease."

Ledesma is dedicated to solving important questions for the population's health and is focused on asking about and researching the ever-shifting questions in his field.

Consider acknowledging phlebotomists with a kind word. To put it in perspective, "Phlebotomists are vital members of the health care team," he said. "They represent the laboratory

"The medical laboratory scientists, also trained in phlebotomy, are the professionals who perform the tests and communicate with clinical personnel about the different tests in the lab," said Ledesma. "There are pathologists and advanced practice medical laboratory scientists in most medical institutions that are more than willing to talk to patients and provide consultation on what the laboratory tests are and how your result impacts your health."

In 2018 Mr. Ledesma received the Mentorship Award by the American Society for Clinical Pathology for his commitment to the field of Pathology. In addition, he serves as a resource for regulatory compliance in laboratories across Oklahoma and Texas.

### Health district awarded \$96,827 Community Enhancement grant

The San Diego County Board of Supervisors approved a \$96,827 Community Enhancement grant to the Fallbrook Regional Health District.

The supervisors approved the grant on a 4-0 vote April 4 with Nathan Fletcher absent. The health district will use the money primarily for coronavirus outreach and marketing materials, but a staff reception position and the South Brandon Road building's heating, air conditioning, and ventilation system will also be eligible uses for the grant funding.

Community Enhancement funds, which are for the most part generated from the Transient Occupancy Tax on lodging facility rooms, are intended to promote tourism including visitors from other parts of the county. The American Rescue Plan Act of 2021 included \$362 billion of Coronavirus State and Local Fiscal Recovery Funds allocations for eligible state, territorial, tribal, and local governments.

The funding addresses the public health emergency and economic impacts of the coronavirus epidemic and can be utilized for four eligible categories: mitigation of negative economic impacts, premium pay for eligible workers performing essential work, provision of government services lost revenue would have eliminated, and necessary infrastructure investments including water, sewer, and broadband.

The San Diego County Board of Supervisors opted to augment Community Enhancement budgets which utilize general fund revenue with APRA funding which can assist non-profit organizations in providing essential services to county citizens.


Each county supervisor recommends the allocation of his or her Community Enhancement funds, although those allocations must be approved by a majority of the board. Supervisor Jim Desmond recommended the use of his District 5 ARPA funds for the Fallbrook Regional Health District grant.

The Fallbrook Regional Health District provides community wellness and health education services to more than 56,000 residents in Fallbrook, Bonsall, DeLuz, and Rainbow.



### **OBITUARIES**



On the fourth of December 2022, longtime Fallbrook resident **Paul H. Schaden** passed away at his home in Denver, North Carolina in the presence of his wife and children after a long battle with Alzheimer's disease. He was 81.

Paul was born Sept. 24, 1941, in Sacramento, the first-born son of Harold and Margaret Schaden. After graduating with a degree in fire science from Sacramento City College in the early 1960's, Paul moved to Southern California where he became a seasonal firefighter with the California Division of Forestry, today's Cal Fire. Around this time, Paul also joined the Air Force Reserve eventually rising to the rank of Technical Sergeant.

In 1970, Paul met and soon married Evelyn Texanna, who would remain his devoted wife for the next 52 years. Soon thereafter, Paul was promoted to Captain in the CDF and transferred to the San Diego Ranger Unit, first to the Red Mountain and then the De Luz fire stations in Fallbrook, where Paul and Tex settled down and started their family.

The birth of their first daughter, Wendy, was followed in quick succession by son Doug and then daughter Stephanie.

Also in the early 1970's, Paul left the Air Force to further his military career in the California Army National Guard, receiving his commission from then Governor Ronald Reagan. Civic responsibility and public service were among Paul's core principles. As such, Paul was a member of many service organizations including the Kiwanis Club, Knights of Columbus and Toastmasters. Paul was also an Elk and a Moose. He served on the Central Committee of the San Diego County Republican Party, was twice elected to the Fallbrook Union Elementary School District Board of Trustees and served multiple terms on the Fallbrook Community Planning Group.

After his retirement from the CDF, Paul served on the board of the North County Fire Protection District and as a Station Captain for the De Luz Volunteer Fire Department, maintaining his long relationship with the De Luz community.

In early 1995, after 35 years in the Armed Forces, Paul retired from the United States Army Reserve with the rank of Major. Paul was a proud "Mustang" – the term for a commissioned officer who started their career as an enlisted man.

In October of 1995, while on duty with the CDF, Paul suffered a massive stroke, the effects of which would challenge him for the rest of his life. Being told he may never walk again, Paul displayed his indomitable spirit, famous tenacity and indefatigable work ethic and was ambling about with the aid of a cane within just a few months.

Though he struggled with partial paralysis and aphasia, which affected his speech, his mind remained sharp, his dignity and example never suffered and his service to his community remained tantamount to his recovery.

After Paul's Alzheimer diagnosis, Tex made the decision to move to North Carolina to be close to Stephanie and her family who could provide the emotional and logistical support that Paul would need in his final years.

Paul is survived by his wife Tex; daughters Wendy (Uly) and Stephanie (Michael) and son Doug; four grandchildren, Sam, Joe, Claire and Morgan; his sister Carolsue (Ted) and brother Allan (Sue) and various cousins, nieces and nephews.

His funeral mass was celebrated in Denver, N.C., followed by a wake in Fallbrook at Pala Mesa Resort, and inurnment in Sacramento in the family plot at the Old City Cemetery.

#### Kicking It: A month in Paris, Day 5

Saturday October 6, 2012: We wake up to another drizzling gray sky. Oh, well. We are Parisians now, weather be damned. Our plan is to visit the White Basilica perched on the horizon across town.

Setting off from the left bank, our bus bounces along tree lined streets over the Seine to the Arc de Triomphe circle where we will transfer to the bus that takes us out to Montmartre.

We traipse across several busy streets at the cross walks to end up at the bus stop we believe is ours. Hoping to confirm this is the bus going to Montmartre, in my best pidgin French, I ask the driver if we're headed there?

At first, I thought I had insulted him because he instantly stomps on the brakes. All of us still standing lurched forward as he opens the folding door at the red light.

In his best pidgin English, he says we are "on the wrong bus." Oops, it seems to be our fait accompli trying to get around Paris.

Our driver points across the way where we need to go to catch the bus to Montmartre. It's on the 'other corner.' But, of course, it is.

Actually, he drops us next to the busiest roundabout in the world, the not so merry-go-round Arc de Triomphe. There are 12 avenues dumping traffic into a four-lane racetrack, with all of the cars rocketing around the Arc at grand prix speeds, this melee of honking horns is a disorganized swarm of pandemonium. We can't cross through this!

There isn't any way to cross at street level from this side of the Arc which is why, to get to that other corner, we'll need to go underground. The stairs taking us there under the road lead into a tunnel below the mayhem. We pause long enough to read about how to get to the top of the Arc de Triomphe and agree to leave that for another day.

As we scoot through the passageway we hear "La vie en rose" playing on an accordion. VJ comments, "Now that's what I thought Paris would sound like." It is our first moment.

Stepping up out of the tunnel, we land at the top of the Champs-Elysée. The crosswalk leads to our pre-designated corner with a few minutes to spare just before the bus to Montmartre arrives. In those few minutes, I spy the Louis Vuitton MotherShip. But what a dichotomy, across this grand boulevard sits a McDonalds. It is another bouncy ride through traffic filled narrow streets to get us to the Piqualle bus stop. From our bus seat we can just make out the dome. Now, all we have to do is make our way up the hill to Le Basilique du Sacré Coeur.

lined with tiny shops all filled with souvenirs. But why does every shop have a bin filled with material scraps outside its front door? Are there that many quilters in Paris?

Anyway, dodging our way through the tangle of humanity, we slip by the guy hustling his shell game and sneak past all of the other people waving stuff in our faces, finally getting to the bottom of the steps leading up to the Basilica.

And wouldn't ya know, just like the lawns across from the Louvre, clusters of hawkers impede our way. As they swarm around us, I thrust a flat palm out and say "no." Hmph. It works. They politely turn to find friendlier customers as we find a low wall under some oleander trees to eat our lunch.

I know why this is called the "Hill of Martyrs." There must be as many steps up to the church as Christ's trudge to the mound. Finally making it to the top, we pause on the landing to catch our breath and to enjoy the view. Naturally, it's now raining, so this time, I'm happy to see hawkers selling umbrellas. We buy a pair for 20 euros.

Glad for the protection inside the chapel, we are immediately hushed by a docent. It's a reminder, this is a house of worship. Quietly we continue along the track skirting around the pews filled with devotees to their prayers. The runner takes us by gigantic statues of saints regally poised on tall pedestals, by multiple prayer alcoves decorated with elaborate frescoes, and many candle-lighting stations with kneelers.

Continuing behind the altar and around to the other side, a lady looks up from her rosary just as I come into view, we share a smile and a nod. Maybe she'll add a Hail Mary for me on this Hill for Martyrs.

Exiting through two massive 15th century doors, we pause on the steps long enough to catch the sights. It is a spectacular view of the entire city. We can see the Eiffel Tower, the Arc de Triomphe; actually, we can see all of Paris from here.

With our parapluies (umbrellas) at full mast, we cut across the church parking lot, and around the corner to find the village. In addition to the Basilica, Montmartre is known for its artists' colony. The courtyard is pretty empty today, guess the rain is keeping them away. Walking up the main street we spot a café and snag an outdoor table. I have an espresso with a lemon twist and VJ orders a glass of red wine. It feels good to sit down. We watch as a bus passes our table and stops close by. It appears we've found our ride back down the hill. Well, it seems like this day is filled with adventure ergo our ride down the hill. The driver squeezes through car-lined streets, brake-brake, brakes around narrow corners, creeping down the hill just in time to catch a ride back to the 7th. It is a harrowing trip down and reminiscent of slinking down Lombard Street in San Francisco, only this street is skinnier.

#### California's business climate – Better or worse?

California has long been recognized for its unfriendly business climate. During the pandemic, a bad situation got worse when the state forced thousands of mostly small businesses to shut down, driving many companies into bankruptcy and forcing layoffs for thousands of workers.

The last thing we need now are more laws imposing greater burdens on the businesses that survived, and in many cases are still trying to recover.

Unfortunately, some in Sacramento don't get that, and apparently want to make matters worse. The California Chamber of Commerce has just come out with this year's "Job Killer" list, legislation the chamber feels will increase the burden on California's business community.

The list includes legislation that would prevent employers from considering conviction history of applicants or existing employees when making employment decisions, that would impose a de facto ban on new warehouses in California, that increases the state's greenhouse gas reduction goals from 40% of 1990 levels to 55% by 2030, removing 17 million gas-powered cars from our highways in the next 10 years.

Other legislation would impose huge tax increases on property or wealth, including income earned in other states. What about gasoline prices? There are no real plans to cut costs by increasing supply or refining capacity. Instead,

legislation has been introduced (and passed!) that imposes increased taxes on oil companies. Proponents acknowledge costs for consumers may increase - but they don't care!

These are just a few of the wrongheaded proposals impacting businesses that have been introduced in Sacramento this session. As a small business owner, I've long supported reducing burdensome and unnecessary regulations that strangle small businesses. Fortunately, last year most of the Job Killers identified by the Chamber failed to pass. Hopefully, most of these new proposals will meet the same fate.

#### A new chief administrative officer

While most of the attention at the County Board of Supervisors has been on finding a replacement for District 4, another vacancy is just as vital. The chief administrative officer (CAO) is responsible for managing the day-to-day operations of the county government and implementing the policies and directives of the County Board of Supervisors. The CAO is similar to the CEO of a business or a strong city manager.

Here's the breakdown of how it works. The residents of San Diego County are ultimately in

charge. You elect the Board of Supervisors. The Supervisors are essentially the Board of Directors, but five people can't run the organization. So, administratively, and operationally, the CAO is at the top of the county's org chart. They are ultimately responsible for the performance of the county's 20,000-person workforce and the \$8 billion budget.

The CAO should not be a political position. The CAO instead prioritizes the interests of the County of San Diego and the people it serves rather than advancing a particular political agenda or serving the interests of a specific political party or individual.

Helen Robbins-Meyer is the current CAO and she will be retiring shortly. It's a very difficult leadership and management position, and I believe she's done a great job for the county. While different voices and people have come on the board, she's continued putting the interests of San Diegans first.

As we move forward, the chief administrative officer's hiring process should be completely restarted to exclude any of Nathan Fletcher's influence. The hiring process should also be done in a transparent way that allows San Diegans a chance to weigh in.

### Review of all things Real Estate: Prices are stable

The below article was written by Ben Verde who is a staff writer for Inman News, one of the most respected real estate news sources in America. My article last week dealt with this subject on the micro level of Fallbrook-Bonsall plus a mention that all North County markets were experiencing the same phenomenon, stable prices despite ominous predictions of dramatically falling prices. Verde's article describes the same thing but treats it from a macro perspective of the entire country. Interestingly, we both arrived at the same conclusion, I'm glad he agrees with me. For two weeks straight, we have had five new listings come onto the local market, so his statement that "we'll see more listings over the next several months" seems to be playing out in our market. He agreed with me again: more listings on the market and that properly priced properties sell. Ole Ben is a pretty smart guy; read on for the rest of his story.

Home sales are cooling – but the competition is red hot. What gives?

Record-low inventory has resulted in intense competition among home buyers even in markets where home sales are floundering, according to new data released Thursday by Redfin,

New listings plunged 21.8% from the same time last year during the four-week period ending April 2, one of the most significant annual drops since the beginning of the pandemic. The drop has resulted in an unseasonal decline in inventory at the start of spring, typically the busiest time of the year for home buying, according to the report. The few homes that are listed are getting snatched up fast, according to Redfin. And among the homes that go under contract, nearly half are doing so within two weeks. That's up from just a quarter at the beginning of the year. Today's supply of homes for sale would take 2.8 months to sell at the current homebuyer consumption rate - a sharp drop from a threeyear low of 4.5 months recorded at the beginning of January, and up from a near record-low of 1.9 months recorded a year ago. Pending home sales remain 19% lower than they were a year ago, partly due to so few new homes hitting the market, with would-be home sellers sitting on the bench while mortgage rates hover above 6%. "Elevated mortgage rates are perhaps an even bigger deterrent for would-be sellers than for would-be buyers," Redfin Deputy Chief Economist Taylor Marr said in a statement. "Giving up a 3% mortgage rate for one in the 6% range is a tough pill to swallow. The lack of homes hitting the market explains why the market is moving fast even though sales are still down. The lack of new listings is also one reason why sales are down: Buyers can't buy if sellers don't want to sell." While new listings are down in every major metropolitan area, the trend is more extreme in some areas. In Denver, new listings are declining at approximately the same rate as the national pace, creating an environment where sellers have the upper hand as long as their home is priced well. "Shiny new listings are getting multiple offers and selling fast. The caveat is that they have to be priced correctly from the beginning," Redfin agent Stephanie Collins said in the report. "Sellers are hesitant, partly because it's not spring 2022 anymore. I'm reminding potential sellers that buyers are out there, and some homes have bidding wars - they just need to price a bit lower than they would have a year ago." Conversely, in Austin, inventory is piling up. The city has a 4.4 month supply of homes more than almost anywhere in the country - and prices are down 15% year over year. "Buyers have more power right now," Austin Redfin agent Andrew Vallejo said in a statement. "The silver lining of high rates and the slow market we've been experiencing here is that some locals are able to buy in neighborhoods they couldn't have gotten into last year and get contingent offers with small down payments accepted. But attractive homes that are priced competitively are selling quickly. Sellers are starting to notice, and they're prepping and pricing their homes accordingly. I think we'll start to see more listings over the next several months."

Caitlin Cunha and Hillary DeCar, two professionals at Del Rey Avocado, are recent BOLD graduates.







#### San Diego County's largest cleanup effort returns on Earth Day

SAN DIEGO COUNTY – I Love A Clean San Diego (ILACSD) is set to host the 21st anniversary Creek to Bay Cleanup on Saturday, April 22, from 9 a.m. to 12 p.m. – on Earth Day. There are three cleanup sites in this area, Old River Road Street Sweep in Bonsall, Live Oak County Park in Fallbrook and Rainbow County Park in Rainbow.

The event is the region's largest one-day environmental volunteer effort on Earth Day, with over 100 cleanup sites around the county. I Love A Clean San Diego expects more than 5,000 volunteers of all ages to participate. Free online registration is now open at <u>https://</u> cleansd.org/creek-to-bay/.

"Our beaches and waterways are some of San Diego's greatest assets and deserve our care," said San Diego Mayor Todd Gloria. "This family-friendly event has a positive impact on our region's environment and reinforces for younger generations the importance of doing your part to make the world better and cleaner."

About 80% of all marine debris begins inland, and all residents of

San Diego County live in one of 11 watersheds, which all have their own habitats and lead to the bays, beaches, and ocean. Litter enters local watersheds and flows out to the Pacific Ocean, becoming a harmful threat to the health of both marine wildlife and residents. Single-use plastics are the most dangerous products, which break down into micro-plastics and can be ingested by animals and humans.

"With the recent rain activity in San Diego, we anticipate more litter and debris traveling through our waterways and into our shared green spaces," said Ann Marie Sack, community engagement director. "What better way to celebrate Earth Day than to volunteer and prevent this pollution from entering our stormwater systems and flowing into local waterways and the ocean."

Since its inception, Creek to Bay volunteers have cleared over 2.4 million pounds of pollution from communities across the county, preserving the region's natural environment, waterways, and ocean. *Submitted by I Love A Clean San*

### Ag pass offers help during disaster

Disasters and wildfires threaten lives and businesses in San Diego County each year. Often people are forced to gather up their most important possessions and evacuate to safety. But commercial livestock operations may be too large to evacuate all their animals immediately and need to return as quickly as possible to care for them.

Farmers also must abandon their operation, leaving crops and critical infrastructure unattended for extended periods. Now, operators can apply for an Agricultural and Livestock Pass program to return to an evacuated area to help when the threat diminishes.

When a mandatory evacuation order is given, all people, including Ag Pass holders, must evacuate. When fire and law enforcement leaders allow, Ag Pass holders will be able to return to the area to move, feed and provide veterinary care of livestock, or work on irrigation systems, farm equipment and other essential infrastructure.

Ag Pass access is limited to daylight hours and doesn't guarantee entry to an evacuated area. Fire and law enforcement officials make the decision for entry based on fire behavior and public safety.

To take advantage of the program, commercial operators and managerial employees must attend a four-hour fire safety training and take annual refresher training. To date, 76 Ag Pass identification cards have been issued to individuals at 28 companies in the unincorporated areas of the county.

The pilot program started last year was limited to cattle and equine operations. Tuesday, April 5, Supervisors approved the immediate rollout of full implementation of the Ag Pass program, offering access to more than four thousand commercial agriculture and livestock operators in the unincorporated area.

# SDG&E seeks federal funds for wildfire safety efforts in high fire threat district

SAN DIEGO – As part of its commitment to reduce the impact of infrastructure costs on electric rates, San Diego Gas & Electric has submitted an application to the United States Department of Energy seeking up to \$100 million in federal funds through the Grid Resilience and Innovation Partnerships Grant program, which is part of the federal Infrastructure Investment and Jobs Act.

If awarded, the grant would elp offset the costs of wildfire hardening efforts on and around federally recognized Tribal Nations' land within SDG&E's service territory. Pending final approval from the California Public Utilities Commission, the federal funds would be matched with an additional \$100 million from SDG&E. "Our region has the most federally recognized Tribes of any county in the nation, and all are located in areas facing the highest risk for wildfire. These funds would help us continue

to work with Tribes to provide safe and resilient energy in the face of a changing climate," said Caroline Winn, CEO of SDG&E. "If approved, this grant would not only help advance wildfire safety initiatives planned on Tribal lands which have experienced wildfires and Public Safety Power Shutoffs in the past, but also plays a key role in our strategy to reduce energy costs for customers."

As the company prioritizes strategic undergrounding of more power lines, the grant would help SDG&E leverage a good portion of its existing and planned fire hardening efforts over the next three years across the majority of Tribal Nations the company serves. The funding would further the company's efforts to strengthen its energy infrastructure and create communities that are safer, stronger and healthier by hardening approximately 70 miles of SDG&E's electric grid. This includes undergrounding approximately 64 miles of power line and covering 6 miles of line with covered conductor, benefiting up to 10 of the region's Tribal communities.

Seeking state and federal funds to pay for climate adaptation measures is an important element of SDG&E's four-part strategy to lessen the financial burden and improve affordability for customers which also includes:

 Pursuing additional federal funds available by maximizing federal tax credits for battery storage and microgrid facilities that can be refunded to customers;

- Advocating for legislation (AB 982) to remove costs from electric rates that could reduce monthly bills up to 7% and legislation to spread the cost of wildfire safety improvements over a longer period of time to reduce rate impacts;
- Modernizing the way electricity is priced; and
- Stabilizing natural gas bills by advocating for improved utilization of existing infrastructure

anticipates receiving outcome notification from the DOE this summer. Prior to acceptance of any grant that is awarded, SDG&E will also need to receive CPUC approval. Then construction would take place between 2024 and 2026. If the grant application is denied, the company still plans to move forward with the fire hardening projects pending approval from the CPUC.

When you meet someone new through a dating app or other online platform, the excitement about a new prospect can lower your instinct to sense when something is amiss.

Instead of questioning what would ordinarily be suspicious, you might explain it away. But here is why you should be skeptical when communicating with someone you've met online.

If you are lucky, the worst of it will simply be that profile photos are not an accurate reflection of how the person you are communicating with really looks.

If you're unlucky, though, the profile is a work of fiction, and the scammer is using it to get money out of unsuspecting suitors.

They will hook you with attention, the appearance of great wealth or business success, common interests, or brave stories of their military service.

But when the conversation turns to loans, wiring money, sending cryptocurrency or temporary cash advances because of a dire situation, that's your cue that your online sweetheart is a trickster looking for easy money.

Before you think it can never happen to you, consider the statistics. According to the Federal Trade Commission, nearly 70,000 people reported a romance scam in 2022 and the reported losses were a staggering \$1.3 billion.

More than 19,000 people in California fell prey to romance/ confidence scams in 2022 with losses totaling more than \$775 million according to the FBI's Internet Crime Report.

California is a breeding ground for scams of all types and the state tops the list for having the most victims according to the FBI report. In California alone, victims lost \$2 billion to fraudsters last year.

The most common line tricksters use to ask for money is that someone they know is sick, hurt

- Someone I know is sick, hurt or in jail.
- I can teach you how to invest.
- I'm in the military far away.
- I'm in a faraway country completing a lucrative business deal.
- I need help with an important delivery.
- We've never met, but let's talk about marriage.
- I've come into some money or gold.
- I'm on an oil rig or ship.
- You can trust me with your private pictures.
- Before your heart goes soft, follow these tips:
- Do not send money or gifts to anyone you do not trust or have not met in person.
- Do not agree to receive money, cryptocurrency or packages and send it on to someone else. You could be opening yourself up to becoming a money mule or an accessory to criminal conduct and committing crimes yourself.
- Scammers will move the conversation off the dating app to avoid detection by the dating site.
- Don't believe tough-luck stories requiring money. Ask questions and be aware of inconsistencies.
- Use Google image search to check your online sweetheart's photo. If the same image shows up with a different name, be suspicious.
- If you decide to meet your online suitor in person, meet in a public place the first few times and make sure a trusted friend or family member is aware of the meeting.

Remember the saying about not judging a book by its cover? That applies in online dating. Ask questions and be aware that sometimes a person's character may not match their profile photo.





### **Local Doctor Helps Legally Blind to See Again!**

Dr. Richard Shuldiner helps macular degeneration sufferers with reading, driving, TV, and maintaining independence.

Pete T., an 83 year-old retired engineer from Palm Springs thought that his driving days were over. "I could not read the street signs soon enough and it made me nervous."

Helen T. retired teacher, 74, from San Diego wanted to be able to read and write more easily. She wanted to see her grandchildren singing in the church choir. ### Historic "never seen before" chess games with Bobby Fischer discovered in Fallbrook

to record the games.

The games were recently analyzed by John Knott, coauthor of the book Blindfold Chess (McFarland 2009). Knott concluded that Sayyah's chess abilities were that of a keen amateur. Since Fischer and Sayyah were socializing rather than officially competing, it is assumed that these games do not represent either player's top performance.

As a side note, Sayyah revealed to Thomas that one of the games was played by both Fischer and himself in a blindfold style. Blindfold chess, also known as sans voir, is played without looking at the chess board. In this case, both players verbally recited moves, remembering each move to the end. Knott's analysis of the games reveals that given one of the games was played blindfold, it was the second game.

Thomas recalls Sayyah showcasing his game notations at a chess club they both belonged to in Marietta, Georgia, a few years after the games took place. Thomas had no idea in those days that these documents would be so intriguing today.

Fischer and Sayyah have since passed, and these games give them new life. Their game record sat in Don's storage for many years. The documents were discovered after Thomas' wife Fran suggested that he do some spring cleaning in his office. The serendipitous discovery of the Fischer-Sayyah games inspired Thomas to get back into promoting chess.

What makes the games between Fischer and Sayyah special is that neither has been included in any collection of Fischer's previously known games. They reveal new insights into his approach to the game.

According to experts who have analyzed the documents, Fischer's play in the blindfold game was aggressive and precise. He showed abilities that had made him a world champion, despite his 15-year absence from the formal games.

Since Fischer is assumed to have been at ease during these particular games, we see a hint of mischievous taunting in his moves. It reminds one of how killer whales play with seals for several minutes before eating the poor pups.

Fischer, who died in 2008, is considered one of the greatest chess players in chess history. He was known for his fierce competitive spirit and unconventional playing style. Fischer was the youngest player to win the U.S. Championship at age 14. He became the World Chess Champion in 1972 after defeating Boris Spassky in a highly publicized match in Reykjavik, Iceland.

The discovery of Fisher-Sayyah's long-lost games is a rare and exciting opportunity for chess fans to see Fischer in action in two games that have never been seen before. The games are expected to be analyzed and studied in depth by other chess experts and enthusiasts, providing new insights into Fischer's approach to the game at that time. These games are a testament to Fischer's enduring legacy as one of the greatest chess players of all time and a reminder of the importance of preserving and exploring the history of this beloved game. The discovery of these previously unknown games

reminds us that there is always more to learn about chess and the players who have made it great. It is a testament to the popularity and fascination of this ancient game that continues to captivate players and fans everywhere.

Thomas plays chess at the Fallbrook Senior Center chess club Tuesdays from 9-11 a.m. and online at Chess.com with his good friend, Jim McRay – the Fallbrook Library chess organizer. Finding these history-making chess games has also inspired Thomas to encourage others to develop a love for chess.

In April, Thomas plans to bring several chess boards to the Saturday Farmer's Market in Fallbrook. Each week throughout the summer, visitors can network with other chess enthusiasts and play some casual chess games at his chess tent. Those who stop by the chess tent can enter a raffle to win a free chess board.

Chess enthusiasts are excited after witnessing the discovery of two never published chess games featuring the late Bobby Fischer, one of our history's greatest chess players. The two games, discovered by Don Thomas of Fallbrook, shed new light on Fischer's playing style over a decade after his 1972 World Champion match.

Fallbrook & Bonsall

The games were played on Nov. 29, 1987, at the Marriott Marina Hotel in Newport Beach, California. In the late 1980s, Fischer was on hiatus from the rigors of chess. On this day, he played a casual game with his friend, Michael Roman-Sayyah. Sayyah was not a professional chess player. During that time frame, he ran a small

professional

chess organization. It can only be speculated, but it is thought that Sayyah may have been attempting to get Fischer interested in working with his chess organization, and the games were simply an icebreaker to the business meeting.


In 1987, any serious chess player would have been thrilled to play Fischer. The most clever move Sayyah made that day was

Fischer, white, pushes Sayyah, black, into a poor position on turn 10; black's king is open to attack along the G column.



Knowing he has the initiative in the game, Fishcher allows black to advance his queen all the way to AI, placing his king in check. He defends with his knight and leaves black few options to advance. Fischer is now free to push his own offensive which results in mate 7 moves later.





### CIF allows split dead period

The CIF San Diego Section has a "dead period" in which contact between coaches and studentathletes is not allowed. The period is 14 days, and schools can now split that no contact period into two seven-day periods.

A unanimous CIF Board of Managers vote Wednesday, April 5, approved a revision in the language which allows schools to split a no contact period while also allowing the retention of a 14-day consecutive period.

"This would be another option," CIF commissioner Joe Heinz said.

In 2002, the CIF implemented a two-week period which prohibits participation or scheduling of organized practices, student-led team practices, team participation in tournaments or clinics, issuance of equipment, school site physical examinations and organizational meetings. Individual students are allowed to attend a clinic or tournament, and a weight-training school class that an athlete is not required to attend does not violate the regulation. The prohibition against team activity rather than activity involving an individual student-athlete allows studentathletes with a relative coaching at the school to discuss athletic matters or participate in informal athletic activities.

Before 2015, the CIF commissioner annually set a specific two-week "dead period" for the entire section, although if a school principal submitted a written request for an alternative 14-day period the commissioner had the authority to grant that. A 2015 change allowed schools to select a two-week dead period for each sport, although the no contact period still needed to be for two consecutive weeks. Each school submits a form to the CIF office stipulating the starting and ending dates of the no contact period for each sport. The dead period can start no earlier than the close of school and no later than July 19, a date which would end the no contact period Aug. 2. Because the no contact period is during the summer the prohibition against team camps, clinics and tournaments applied only to fall sports and not to winter or spring sports. In 2018, the CIF allowed such activities supervised by the school coach or coaching staff members and within two

weeks of the start of fall practices. Eliminating injuries during the season, especially in sports such as cross country where endurance tolerance can be beneficial if a runner builds base miles during summer training, was also a reason for that modification which did not eliminate the dead period.

The option to split the no contact period allows more flexibility which may enable schools to have more actual no contact time for student-athletes which could include academic commitments. The change may allow more flexibility in summer vacation schedules both for the athlete's family and for coaches' families. It may also be possible for a school to have a single dead period for all sports, which would be to the benefit of multi-sport athletes.

"If you don't want to split, you don't have to," Scott Giusti, director of physical education, health and athletics for San Diego Unified School District and SDUSD representative on the CIF Board of Managers, said. "What we're asking is for the flexibility."

### CIF planning to split Division V for playoffs

In 2013, the CIF San Diego Section's Board of Managers transitioned CIF playoff divisions from enrollment to competitive balance. That placed small schools with talented programs (including private schools with no limited attendance areas) into higher divisions while placing some programs of larger schools into lower divisions.

The result meant that schools with larger enrollments often won CIF Division V championships, and in many cases the Division V playoff berths were dominated by larger schools. A proposal by small schools to split the Division V playoffs based on enrollment had no opposition during a first reading at the April 5 Board of Managers meeting, and while the first reading was a non-voting item, the proposal is expected to pass at the May 17 Board of Managers meeting.

"I'm very excited to bring this forward," said CIF commissioner Joe Heinz. "I think there's something we can do."

Once all five divisions have been set, Division V will be reranked based on the current year's total school enrollment. "It's just Division V," Heinz said. "It would not change our current competitive equity."

For each sport, Division V would be split in half based on the total number of Division V schools that year. Schools whose enrollment is in the top half would be in Division V-A and schools in the bottom half would be placed in Division V-AA.

If a Division V-AA school requests to move up to Division V-A, the CIF will check with the schools at the bottom of Division V-A and inquire if those schools would like to move down to Division V-AA.

Teams in both Division V-A and Division V-AA would continue to use Division V points for the power rankings which are the primary factor for CIF playoff selection and seeding.

For current CIF playoffs with 12team brackets, the playoffs would be split into eight Division V-A teams and eight Division V-AA teams. For 16-team brackets, the revised playoffs would have 12 Division V-A entrants and 12 Division V-AA berths. Only the Division V-A champion would be eligible for entry into state or regional playoffs. "I think it's an awesome idea. I couldn't agree with it more. It's going to bring equality to the smaller schools," said Julian Union High School District superintendent Michael Dodson, who is the JUHSD representative on the CIF Board of Managers.

Escondido Adventist Academy, with 43 students, is the smallest school in the San Diego Section. Borrego Springs High School had 124 students at the start of the school year and is the thirdsmallest public school. Bonsall High School began 2022-23 with 318 students, making Bonsall the fourth-smallest public school.

"This is going to benefit our teams because we're going to play against competition that is more on our level," said Bonsall High School Athletic Director Andrea Breuninger.

"This is going to give us more of an opportunity when we make the playoffs," Breuninger said. "We're really anticipating what the CIF board is going to decide."

Last year, Bonsall and Borrego Springs were both league champions in softball. A league champion is guaranteed a CIF playoff home game if the league has at least four teams. Bonsall won the championship for the Patriot League, which had four teams last year.

Borrego Springs was in the Manzanita League and, when Warner did not field a softball team for 2022, the league consisted of only three teams, so Borrego Springs was not guaranteed a home playoff game and the Rams traveled to Bonsall for the first round of the softball playoffs.

The split into Division V-A and Division V-AA would reduce the possibility that the champion of a league with fewer than four schools would be omitted from the CIF playoffs altogether, which was the case with the 2021-22 Warner High School boys basketball team which won the Manzanita League championship but did not have post-season play.

Based on fall 2022 enrollment, girls volleyball would have 17 Division V-A teams with Guajome Park Academy (515 students) being the smallest and 18 Division V-AA teams with The Preuss School (473 students) being the largest. The 19 Division V teams in 11-man football would be divided into nine Division V-A teams (the smallest being Kearny with 1,473 students) and 10 Division V-AA teams (the largest being Clairemont with 843 students).

Cross country divisions have always been by enrollment, so that will not change (that is also the case for golf, wrestling, swimming, and track and field, all of which have fewer than five divisions). The 2023-24 divisions for boys basketball, girls basketball, boys soccer, and girls soccer have not yet been set and the Division V split will also cover the spring sports of baseball, softball, and boys volleyball. Field hockey, water polo, tennis, lacrosse, and gymnastics have fewer than five divisions.

### CIF girls flag football to be fall sport

Girls flag football will be added to the list of CIF San Diego Section sports for the 2023-2024 academic year, and flag football will be a fall sport.

The CIF Board of Managers meeting Wednesday, April 5, included the unanimous approval of flag football as a fall sport. The approval also includes use of the National Intramural-Recreational Sports Association rule book. A separate April 5 vote unanimously approved the CIF master schedule for 2023-2024 which governs permissible dates for practices and contests.

"We're excited about this moving forward," CIF commissioner Joe Heinz said.

Flag football had tentatively been approved as a fall sport for the San Diego Section. Field availability, player availability and compatibility with other CIF

sections were considered.

"We know there are challenges," Heinz said. "We settled on the fall."

Boys football is a contact sport, and the CIF requires a team to have had 14 days of practice before to the first game, while each player must have at least 10 days of practice before being

allowed to compete in a game. Because flag football is a noncontact sport, the CIF will require five days of practice before a game. Football teams are limited to 10 regular-season games, while girls flag football teams will be allowed 20 contests during the regular season.

The National Intramural-Recreational Sports Association focuses on the college level but has a rule book for flag football. CIF girls flag football will have seven girls from each team on the field at one time. The fields will measure 80 yards by 40 yards.

The first permissible day of

practice for the 2023-2024 season will be Aug. 5, the first permissible scrimmage date will be Aug. 11, and the first allowable date for games is Aug. 12. The end of the regular season will be Oct. 27, allowing for an Oct. 28 playoff selection and seeding meeting.

The CIF only administers playoffs for sports in which more than one conference participates – currently only the City Conference has badminton and only the Metro Conference has roller hockey – and the requirement for a formal CIF tournament also includes that the sport is played by at least 20% of the schools.

"It could be an informal tournament," Heinz said.

"I think we're going to have a lot of schools moving forward," CIF assistant commissioner Todd Cassen said.


